8. DAMAGE, LOSS, OR THEFT

The Client assumes full responsibility for any damage, loss, or theft of equipment during the rental period. Repair or replacement costs will be charged accordingly.

9. WEATHER POLICY

- Outdoor setups are subject to weather conditions.
 - The Company reserves the right to reschedule in unsafe weather conditions.
 - Deposits may be transferred to a new date based on availability.
