If I choose to RESCHEDULE my wedding, the deposit will transfer and be used to secure a new date.

- On the day of your wedding, if I perform your services at the salon, you are invited to bring any drinks or food that you will make your day more special.
- Most importantly....please be ON TIME for your wedding day appointments. Even starting 15 minutes late will put everyone behind and I don't want you to be late for your special day!
