1. Complimentary Consultation: Here we will discuss your hair needs and schedule both a practice run and wedding day services. Our contract and wedding day policies will be reviewed and a \$200 deposit will be collected. Your wedding will not be booked until I have a signed contract and deposit.
2. Trial Run for The Bride: This should be scheduled 2 to 4 weeks before your wedding. Bring everything you will wear on your big day. Such as jewelry, veil, and so on. I recommend you

have makeup done prior to the trial to see the whole look come together. At this appointment we will review and finalize your number of attendants getting hair done.

5. Additional Stylist: If you have a wedding party booked with 8+ or limited time in which you can get ready, an additional stylist or assistant may be needed. It is a flat fee of \$50 to bring an extra stylist. The need for one will be discussed at your trial run. This fee must be paid prior to your wedding day.

CANCELLATION POLICY

I do ask that if there should be a need to change to adjust or cancel any of the appointments that all changes are made 1 week prior to the wedding day. If changes or cancelations are made less than 1 week, you are still responsible for paying the full amount stated above. There must be at least 5 services booked in order for me to accept your wedding. If your number drops to less than 5, you will be responsible to pay for their spot.

I, _____ agree to the scheduled appointment times and the prices listed above. I understand and agree to the deposit of \$200 at this time to secure the

appointments. I agree to pay the full balance due 1 week prior to the event. I understand that the deposit will not be refunded. Changes to the bridal party can be made 1 week before. I understand if these changes are made less than 1 week, I am responsible to pay the total amount due and no refund will be given to members of the wedding party who miss their appointment or change their mind on the day of the event. If I choose to CANCEL my wedding due to COVID and no longer need hair services, the deposit will NOT be refunded. If I choose to RESCHEDULE my wedding, the deposit will transfer and be used to secure a new date.

IMPORTANT INFORMATION FOR YOUR BRIDAL SERVICES:

To help me serve you better and ensure that your wedding day runs smoothly, I ask that you and your wedding party please follow these simple guidelines.

- Please arrive with clean, DRY hair. An additional fee will apply if I have to blow dry your hair.
- During your trial run, please bring all accessories to get the feel of the “full look”
- Please bring pictures of different hairstyles that you're interested in for me to look and discuss together the best style for you. Also, bring a picture of your wedding dress.
- On the day of your wedding, if I perform your services at the salon, you are invited to bring any drinks or food that you will make your day more special.
- Most importantly...please be ON TIME for your wedding day appointments. Even starting 15 minutes late will put everyone behind and I don't want you to be late for your special day!
