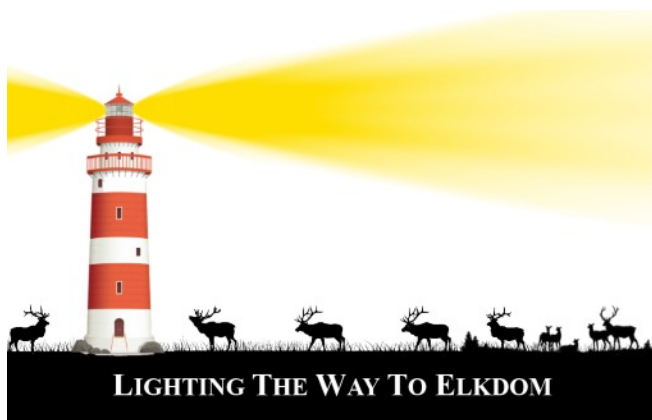



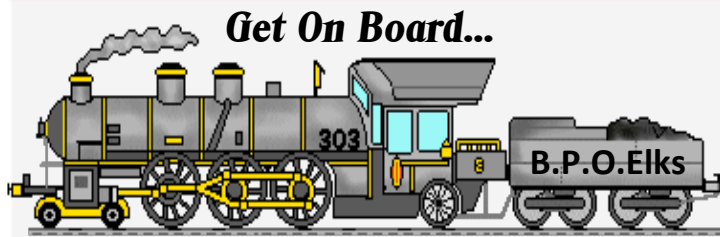

## Did You Know????

**Taken From Grand Lodge Statutes: Section 16.041**

The managing body of the Club shall have the power to suspend a Member from the club for a period not to exceed 1 year for violations of the rules adopted by the Lodge or Conduct Unbecoming An Elk, after 10 days written notice to the Member.

An appeal to the Lodge may be presented by a Member suspended by serving a Notice of Appeal to the Lodge Secretary no later than 10 days after the receipt of written notice of suspension. The execution of the suspension shall be stayed when the notice of Appeal is received pending a Hearing for the Appeal.

The Exalted Ruler will order a Hearing of the Appeal at a regular meeting of the Lodge to be held no later than 45 days thereafter.

A motion to modify or reverse the action of the supervising body must pass by an affirmative secret ballot of two-thirds vote of the member present.

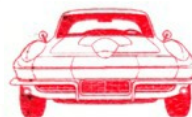

## Celebrating our 50<sup>th</sup> Anniversary... Flag Day

Patriotism has characterized the Benevolent and Protective Order of Elks of the United States of America since the early days of the organization. Allegiance to the flag of our country is a requirement of every member. In 1907, the Grand Lodge of the Benevolent and Protective Order of Elks designated, by resolution, June 14 as Flag Day. The Grand Lodge of the Order adopted mandatory observance of the occasion by every Lodge in 1911, and that requirement continues. The Elks prompted President Woodrow Wilson to recognize the Order's observance of Flag Day for its patriotic expression. But it was not until **1949 when President Harry Truman**, himself a member of the Elks, made the proclamation that thereafter June 14 would be a day of national observance for the symbol of our country. It was through his Elks Lodge in Independence, Missouri, that President Truman got the idea for a national observance of Flag Day.



The Northglenn Lodge has a proud history of performing the Flag Day Service. In the early years the Lodge would perform the service for the membership with the traditional parade of flags representing all different versions from the Pine Tree Flag used in 1775 through the Flag we currently see today. During the 1990's we began performing Flag Day with the Cities in our area. We performed with the City of Northglenn at the Webster Lake facility and with Thornton at their Offices located at 92<sup>nd</sup> and Grant. The Central Northwest District has since moved to a combined service where each Lodge hosts the grand event. At many of the recent services, Northglenn has performed the Flag Retirement Service at the same outing. This is a very respectful way to retire service worn Flags paying the respect that those who have served our great country have earned. This year Northglenn will be hosting the District Flag Day event as part of our 50<sup>th</sup> Anniversary Celebration.
