

Did you Know...

CLEM AUDIN, JR., was a member of the Hotchkiss Elks Lodge #1807. Who died August 3, 1973 as a result of a tragic accident at the Hawk's Nest Coal Mine in Somerset, Colorado. At the time of his death, Clem was serving CEA as 1st Vice President and was due to be installed as State President within 30 days. He was a PER of Hotchkiss Lodge, PDDGER and Ritualist Judge. Evelyn, his wife, created a trust fund of \$100,000.00 with half of the yearly net interest income to be given to CEA to benefit young people in Colorado. ONLY INTEREST INCOME FROM THIS FUND CAN BE USED. Did you know CLEM & EVELYN AUDIN FUND is administered through the Colorado Elks Association? This fund shall be used exclusively for the education, health, development and care of young people 18 years and younger. Eligible recipients are through Lodge Membership, local schools, churches, county social service, police and sheriff departments. Some of the areas this fund is intended for are: clothing, school supplies, registration fees and verified medical situation, glasses and eye exams, Dental costs, hearing aids, sports clothing. Funds may not be used for: tuition, scholarships, groups, continuing medical expenses, food and shelter and anyone who has reached the age of 19 years old. Request for assistance should be directed to your Lodge Secretary.






Greetings from your Lodge Historian, Celebrating our 50th Anniversary
