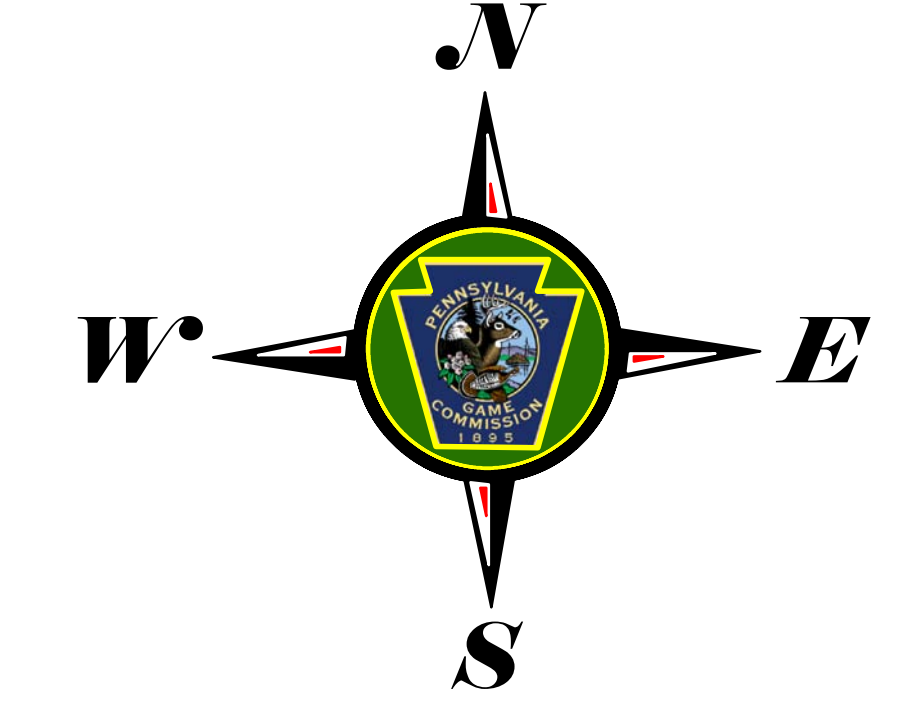

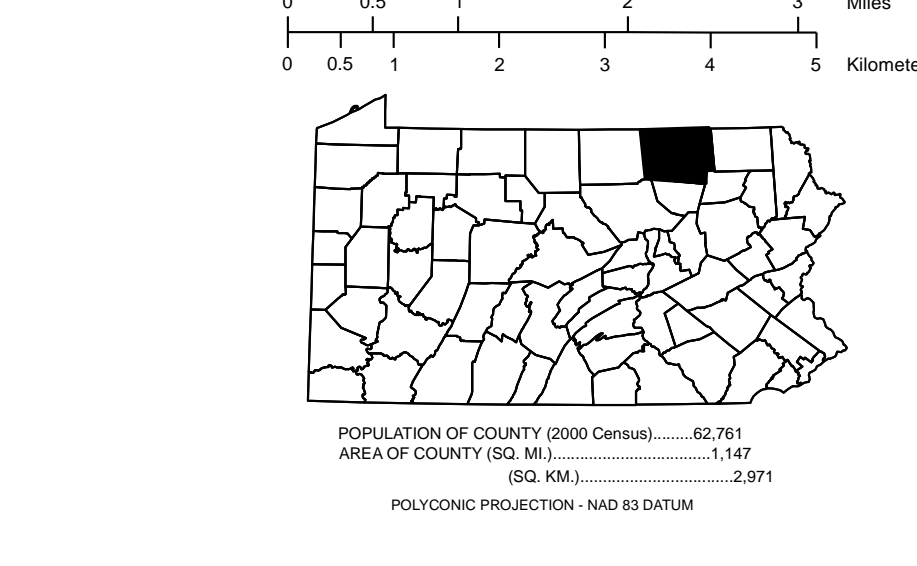

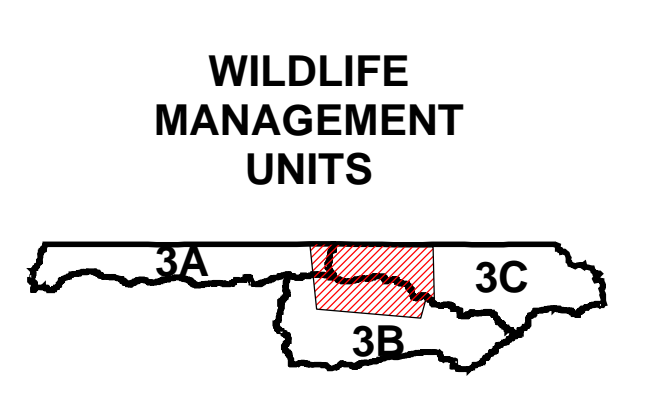

**SPORTSMAN CODE OF ETHICS**

1. ALWAYS OBTAIN YOURSELF A FIELD OF THE LANDOWNER'S PERMISSION TO USE THEIR LAND AND THANK THEM FOR THEIR HOSPITALITY.
2. ALWAYS RESPECT THE RIGHT TO HUNT AND HAZARD OF THE LANDOWNER.
3. LEAVE THE PROPERTY IN BETTER CONDITION THAN YOU FOUND IT.
4. NEVER FIRE GUNNERS TO BURNINGS, FENCES, GATES, CROPS, FIELDS, TREES, BARNYARD, OR LIVESTOCK.
5. NEVER FIRE GUNNERS AS KILLING AT LEAST 100 YARDS AWAY FROM ANY PERSON.
6. NEVER SET TRAPS OR SNARE TRAPS ON ANY LAND.
7. ONLY THE BASIS OF SAFE HUNTING AND HAZARD OF OTHERS TO DO SO TO HILL.
8. ONLY GAME LAWS AND REGULATIONS AND RESPECT YOUR COMPANIONS TO DO SO.
9. ACQUIRE GOOD MARKSMANSHIP AND HUNTING SKILLS TO ENSURE CLEAN SHOTS.
10. BEHOLD YOUR OWNERSHIP AND HUNTING SKILLS TO ENSURE CLEAN SHOTS.
