#### Appendix 2: UISA TIER 2 VIPL 2017/18 SEASON

This past VIPL season was a successful one for UISA. The Storm and Riptide both formed four Boys and four Girls teams. The league was very competitive with league winners of many divisions decided in the last games. This year, the Upper Island teams dominated the girls division by clinching 4 of 5 provincial berths. On the Boys side we are sending one off to provincials. Both franchises continue to support the BCSPL Wave team by promoting and permitting up where possible. Travel issues that were frustrating in the first half of the season were ironed out by a newly adopted Severe Weather protocol document produced by the Storm Steering Committee. This new document will make travel decisions easier and less contentious. The Riptide Steering committee put pen to paper and came up with a fundraising policy that was endorsed by the Storm and adopted by UISA. It will be implemented for the 2018-19 season.

Lower Island's decision to move to regional teams paid off in the U14 division with both teams advancing to Provincials. Lower Island continues to experience growing pains in VIPL due to club politics and boundary issues.

#### Storm;

This past season we had 130 players playing on 8 teams which were made up of kids from all our member clubs.

It was a successful season with 4 teams making VIPL finals and 2 advancing to the provincial championships (U17 Girls and U18 Boys).

It has also been a successful season with several players moving onto BCSPL Wave and many more permitting to help their program.

Storm players and their families enjoyed their first year-end Gala this season – the event was very well received and the celebrations included the first ever Storm scholarships, with three \$500 awards made to deserving graduating players.

#### Riptide:

The Riptide had a very successful season. Six teams made the VIPL finals, with three heading off to Provincials. Every Club on the North Island was represented as well as the North Island Soccer District. The Riptide was well represented in BCSPL and continues to prepare and promote our players to that level.

The Riptide continues to facilitate and promote our players to be able to play at the collegiate level. This year scholarships were awarded to graduating Riptide players from St. Francis Xavier, University of Lethbridge, Peninsula College and Thompson River University. To assist with the financials, four \$500.00 Riptide scholarships were also awarded to deserving applicants in the program. The Riptide continues to invest in Coaches and Coach development. This year we added Megan Jackman as our keeper coach. Megan's addition compliments an already-solid technical staff of Shell Brodsgaard, Ken Garraway, Ash Mohtadi and Steve Hall. In part for his involvement with the Riptide,

Ash was awarded the BCSA Award of Merit this season! Congratulations!

Teams were organized in 6 divisions: Super8 Boys, Super8 Girls, U14-15 Girls, U16-18 Girls, U14-16 Boys, and U16-18 Boys. The season ran from September to March, with a break from mid-December to January 14. Once again, we programmed inter-league games with VIPL teams for the older age groups. Weather was a major impediment after Christmas - most divisions lost some of the New Year portion of their season due to weather.

For the second year, U14-U18 teams participated in the District Pacific Development Cup. Playdown rounds consisted of a home and away series for each pair of competitors selected by random draw. The finals were held on the last weekend of league play to end the season. B-Cup Playdowns in February saw some game cancellations due to weather. Two UISA teams – Alberni Valley U16G and Powell River U14B - advanced to the Provincial B-cup Championships in July 2018. Congratulations! For the first time this year, all district B-Cup reps took part in Coastal Cup games vs Lower Mainland teams.

Again this year, Super8 teams were streamed into ability-based pools after a seeding round, and five jamborees were programmed into the season, including 2 indoors at Arbutus Meadows and the Pacific Development Cup Jamboree in October. Teams from Gabriola and Lower Island joined in some of the jamborees, when space was available. UISA successfully competed for BC Soccer grant funding to support our Super 8 Jamborees.

#### 2) Island Invitational tournament:

The 54<sup>rd</sup> annual Island Invitational tournament was hosted by Powell River on April 28 and 29, 2018. U13 district reps were selected via a round-robin tournament on March 10 and 11, 2018. The U14-U18 Pacific Development Cup winners advanced as the district reps to the Island Invitational finals.

## Appendix 4: Registrar's Report 2018

Registration numbers overall in the district are down 8% from last year's – 5443 players in 2017-18 and 5909 the year before. Club total numbers were mostly down: GYSA had a huge decrease (43%, 2 of 4 house teams) CVUSC and OYSS were down 20%, CRYSA and PRYSA were down 14%, AVYSA was down 5%. In contrast HCFC showed a 5% increase, and MIYSA had stable enrollment. There was also a huge increase in Upper Island players joining BCSPL (up 250%, from 12 to 30)
