## PLEASE READ CAREFULLY BEFORE SIGNING

By registering for and/or participating in the **Mid Atlantic Kayak Open** ("Event"), I acknowledge and agree to the following terms:

### Assumption of Risk

I understand that kayak fishing is an inherently dangerous activity that may involve risks including, but not limited to: drowning, capsizing, collision with vessels or objects, severe weather, changing water and tidal conditions, marine life encounters, hypothermia, heat exhaustion, equipment failure, and physical injury up to and including permanent disability or death.

I knowingly and voluntarily assume **all risks**, both known and unknown, associated with participation in this Event.

### Release of Liability

In consideration for being allowed to participate in the Event, I hereby **release, waive, discharge, and hold harmless**:

- Event organizers, sponsors, volunteers, staff, affiliates, and representatives

from **any and all claims, demands, actions, or causes of action** arising out of or related to any injury, illness, property damage, or death that may occur during or in connection with my participation in the Event, **whether caused by negligence or otherwise**, to the fullest extent permitted by law.

## **Medical Responsibility**

I certify that I am physically and medically capable of participating in this Event. I understand that I am solely responsible for my own safety and medical care. I authorize emergency medical treatment if necessary and agree that all medical expenses are my responsibility.

## **Rules and Safety Compliance**

## **Mandatory Captains Meeting**

## **Alcohol and Drug Policy**
