Learning to Sell and Serve Responsibly

Did You Know?

- ⇒ On average, roughly 40 percent of inmates who are incarcerated for violent offenses were under the influence of alcohol during the time of their crime. (NCADD, 2015).
- ⇒ On average someone is killed by a drunk driver every 50 minutes (NHTSA, 2017).
- ⇒ The average Blood Alcohol Content (BAC) among fatally injured drinking drivers is .15 (NHTSA, 2017).
- ⇒ The risk of death for drivers in single-vehicle crashes with a high BAC is 385 times greater than that of a zero BAC driver. For male drivers the risk is 707 times greater than that of a sober driver (IIHS).
- ⇒ In 2016, there were 10,497 people killed in drunk driving related crashes (NHTSA, 2017).

Who Should Attend?

Any person who sells or serves alcoholic beverages.

- ◇ Bouncers
- ◇ Store Clerks

Why Attend?

There are several reasons why individuals should attend including:

- * Penalties for alcohol violations are decreased.
- * Some insurance companies lower insurance premiums if employees are trained (check with your insurance agent).
- * Underage selling or serving will decrease.
- * Employees will gain knowledge regarding alcohol liability and responsibility.
- * Because the life you save may be your own.
