RULES FOR NOMINATION OF LIFE MEMBERSHIP AND LIFE MEMBERS

- Any financial Member / Life Member of the WCV may submit, to be received by the Committee before July 31st in that particular year, a nomination for Life Membership for a Member who has given long and continued outstanding service to the WVC and meets the requirements for Life Membership.
- A Member may only nominate one Life Membership in the current Club year and must wait for the next Club year to make another nomination.
- A nomination will only be accepted if it is proposed on the committee approved "WCV LIFE MEMBERSHIP NOMINATION FORM"
- Life Membership in the WCV can only be bestowed on one person per year. Any nominations received in that year that are unsuccessful will have to be re-nominated in another year.
- Life Membership is at the discretion of the Committee and will only be bestowed by a unanimous vote of the voting Committee Members.
- A life Member, if they are deemed to have acted in a manner to bring the Club into disrepute, may have their Life Membership revoked by a unanimous vote of the Committee.

Criteria

1. A minimum of 10 years Membership
2. A demonstrated ongoing, regular attendance / support / maintenance of Club Cruises, events and activities.
3. A minimum of 5 years in specific Club roles plus significant contributions to the Club which may include some of the examples below.
 - Club Service both on and off the Committee
 - Cruise scouting or reconnaissance, planning, organising and Leadership
 - Promoting the benefits of the of the Whittley boating lifestyle
 - Regular ongoing involvement of any activities that may include the planning and organisation of WCV Rallies or organising and/or running of or producing training and assistance programs or articles that benefit Club Members.
