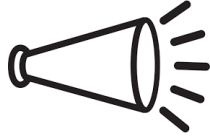

Tell the bill sponsor and all Republican Senate Judiciary Committee members to improve and pass SB 164 (Civil Liability for the Wrongful Death of an Unborn Child)!

In preparation for the upcoming 2026 Legislative Session, **SB 164** will go before its first committee of reference, the **Senate Judiciary Committee**, on Tuesday, November 4th.

Accordingly, please contact the bill sponsor and all Republican committee members (and their aides) to ensure that **SB 164** advances and is improved by:

- 1) allowing for all parents of all unborn children to recover civil damages; and
- 2) removing unnecessary language from the bill that makes it harder to hold accountable abortion providers and those involved in the assisted reproductive technology industry.
