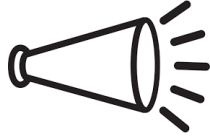

In preparation for the upcoming 2026 Legislative Session, **HB 289** will go before its first committee of reference, the **House Civil Justice & Claims Subcommittee**, on Tuesday, November 18th.

Accordingly, please contact the bill sponsor and all Republican subcommittee members (and their aides) to ensure that **HB 289** advances and is improved by:

- 1) allowing for all parents of all unborn children to recover civil damages; and
- 2) removing unnecessary language from the bill that makes it harder to hold accountable abortion providers and those involved in the assisted reproductive technology industry.
