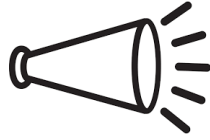

Florida Voice for the Unborn PAC Calls on State House District 10 Republican Candidate Marshall Rawson to Drop Out – and Condemns Florida Right to Life’s Endorsement of Rawson’s Candidacy

Chairman Andrew Shirvell today issued the following statement:

“Based upon [disturbing new information](#) uncovered this week indisputably linking Republican **Marshall Rawson** to the infamous 2017 hate rally in Charlottesville, Virginia, **Florida Voice for the Unborn Political Action Committee (PAC)** is publicly calling for **Rawson** to withdraw from the race for the open House District 10 seat, which spans Baker, Bradford, Columbia, Union, and (part of) Alachua counties in north central Florida.”

Shirvell continued, “**Marshall Rawson’s** [self-admitted](#), unrepentant participation in the Charlottesville rally – alongside members of the Ku Klux Klan, neo-Nazis, and others who despise racial minorities, Catholics, and Jews – is disqualifying. Moreover, his legislative campaign is heavily funded by those same unsavory elements.”

Shirvell further remarked, “In this past August’s Republican Primary Election, **Rawson** was able to defeat his opponent **Chase Brannan**, the son of **Rep. Chuck Brannan**, the current House District 10 incumbent who has reached the end of his consecutive term limit. **Rep. Brannan** has a faithful pro-life voting record and his son, **Chase**, is also staunchly pro-life. **Florida Right to Life**, a longtime member of the state’s do-little pro-life establishment, nonetheless chose to give its [sole endorsement](#) in the Primary to **Rawson**, allowing **Rawson** to [improperly tout](#) his supposed

pro-life credentials to voters just as early voting got underway – and just as questions about **Rawson’s** [support for fringe ideologies](#) were beginning to surface.”

Shirvell added, “**Florida Right to Life’s** endorsement of **Rawson** follows a disturbing pattern. This past January, **Florida Right to Life** [permitted](#) controversial gubernatorial candidate **James Fishback** and his entourage to attend its dinner in Jacksonville. **Florida Right to Life** also helped bankroll a march the following day, in which **Fishback**, [a main speaker](#), repeated incendiary remarks calling for the ‘burning down’ of abortion mills in our state.”

Shirvell continued, “**Florida Voice for the Unborn PAC**, which was officially registered with the state of Florida on August 4, 2026, did not make any endorsements in legislative races during the Primary. Following **Congressman Byron Donalds’** overwhelming win in this year’s Republican gubernatorial contest, **Florida Voice for the Unborn PAC** [proudly endorsed](#) his candidacy on August 31st. **Florida Voice for the Unborn PAC** also plans to announce further candidate endorsements in other important electoral contests prior to the General Election.”

Shirvell concluded, “In light of the new nauseating revelations concerning **Marshall Rawson**, **Florida Voice for the Unborn PAC** will never give him our stamp of approval because he is not authentically pro-life. We also condemn **Florida Right to Life’s** endorsement of **Rawson’s** candidacy and strongly urge that organization to immediately rescind its backing so that House District 10 voters are not further misled, especially if **Rawson** refuses to do the right thing by withdrawing from the race.”

Founded in 2020, **Florida Voice for the Unborn** is a Tallahassee-based grassroots lobbying group that only focuses on pro-life issues impacting the unborn.
