

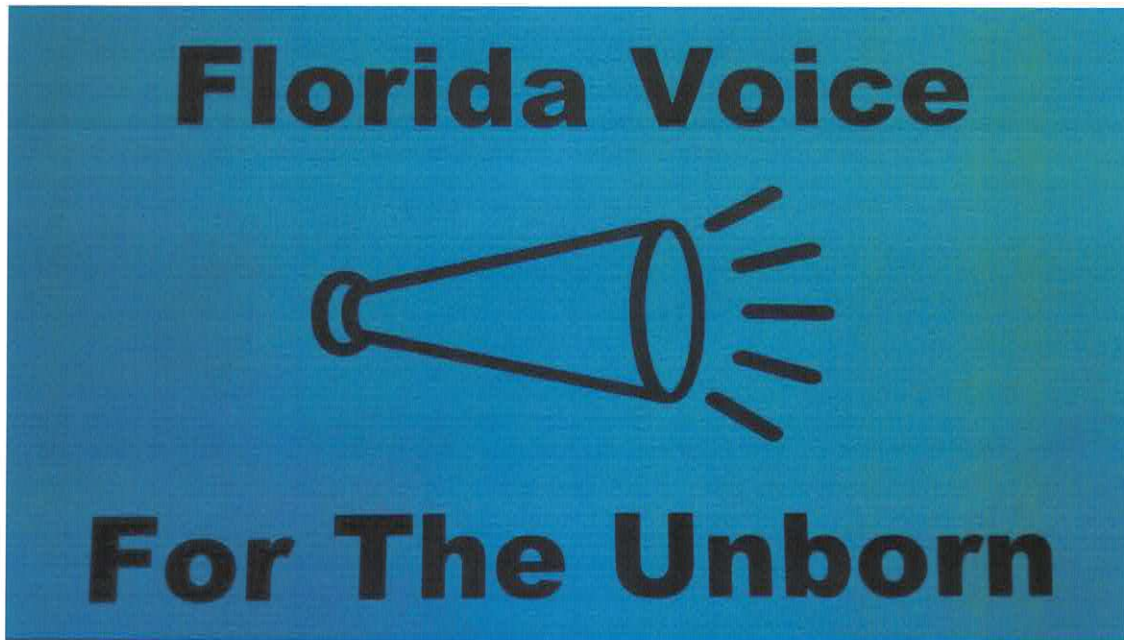
**ACTION ALERT: Help Close FL Abortion Facilities TODAY!**

Dear Friend of the Unborn,

We have an unprecedented opportunity to SHUT-DOWN all Florida abortion mills during this coronavirus emergency.

On Friday, March 20, 2020, Governor Ron DeSantis issued Executive Order 20-72, which prohibits all elective procedures during the emergency so that precious medical resources can be conserved.

Surgical abortions, as well as chemical abortions, are clearly elective procedures. Therefore, under Executive Order 20-72, Florida abortion facilities are now prohibited from offering, performing, or advertising abortions.

Nonetheless, abortions have continued throughout the state because Executive Order 20-72 is not being enforced! In both Texas and Ohio, the governors issued similar executive orders to that of Executive Order 20-72. When abortion facilities in those states failed to comply, the Texas and Ohio Attorneys General got involved. While the abortion facilities in Ohio appear to still be

fighting the closure order, the Texas Attorney General has been much more successful in stopping abortions because he took decisive action by pledging to bring criminal charges against abortionists and their employees!

Florida Voice for the Unborn is now calling upon our own state Attorney General, Ashley Moody, to issue an immediate cease and desist order to all Florida abortion facilities to bring them into compliance with Governor DeSantis' Executive Order 20-72. You can read my letter to AG Moody [HERE](#). Shortly after I e-mailed this letter, I received a call from AG Moody's office! Her staff is looking into the issue – but the longer enforcement is delayed, the longer Florida abortionists have to kill unborn babies.

So, we need to do what was done in Ohio and Texas, which is to ramp-up the grassroots and media pressure. Accordingly, I need everyone on this huge e-list to e-mail AG Moody right now. Go to our website and fill out the form. All you have to do is fill-in your name and e-mail address, and write a message. Your message can be as brief as: "Please issue an immediate cease and desist order to all Florida abortion facilities. They are in violation of Governor DeSantis' Executive Order 20-72. They need to be closed now to conserve precious medical resources!" You do have to write some kind of message before you hit send (and, I apologize for any technical glitches that occurred during our last e-campaign via the website). UPDATE: Thank you to all who contacted Governor DeSantis' office, asking him to veto Senate Bill 698 because it violates the dignity of human life. We are also still waiting for the parental-consent-prior-to-an-abortion legislation to be placed on the governor's desk for signature.
