## Dear Friend of the Unborn:

I hope you had a wonderful Easter/Resurrection Sunday! We now need to spring into action because **House Bill 1221 (Prohibition of Disability Abortions)** is scheduled to be heard in its second (and final) committee of reference **tomorrow**, **Tuesday**, **April 6th**. This bill will stop Florida abortions that are based on a diagnosis of genetic disability.

On March 11th, **House Bill 1221** passed the House's Professions and Public Health Subcommittee 11-to-7. Six pro-abortion Democrats voted against the bill along with one Republican, Rep. Sam Killebrew (District 41 – Polk County). At that hearing, pro-abortion activists and their subcommittee allies put on an unhinged performance that was full of misinformation and outright lies. While Rep. Killebrew did not speak during the subcommittee hearing – and has yet to explain his vote against the bill – the fact that he joined the Democrats in voting against the measure means we need to fight harder and cannot take anyone's vote for granted!

Therefore, in the short time we have been given, I strongly urge you to contact

members of the House's Health and Human Services Committee. The committee vote on House Bill 1221 could take place anytime between 12:30 p.m. and 2:30 p.m. on Tuesday. Below are the simple talking points about House Bill 1221:

- Children who are diagnosed with Down syndrome or another genetic disability prior to their birth should not be targeted for extermination. They are God's children and have the same right to life as all other persons.
- Allowing abortion in Florida based on genetic disability contributes to a
  devaluing of all persons living with a genetic disability. Banning such
  abortions will lead to greater respect for all disabled Floridians.
- This bill rightly does not contain exceptions for rape and incest. The
  manner in which unborn children are conceived is irrelevant. A child
  conceived by rape or incest is no less deserving of protection under the
  law than any other child.
- Prohibiting abortions based on genetic disability is constitutional.
   Mississippi and North Dakota have passed similar bans, which were not challenged in court and are in full effect within those states.

To make things easier, however, further down I have listed all of their e-mail addresses together. You may "copy and paste" these addresses into the "to" header of a new e-mail message. If you choose to use this option, be sure to write a "subject line" such as "Pass House Bill 1221 (Prohibition of Disability Abortions)", as well as write your own unique message and then hit send! We also need to call these committee members. I have listed the phone numbers for each representative's Tallahassee and district offices. Remember, if you can't get a hold of anyone, just leave a polite message. And, again, no matter what – mention that you're with Florida Voice for the Unborn!
