

To all those who signed-up for our e-list this past week: welcome to Florida Voice for the Unborn – a <u>NEW</u> grassroots Tallahassee-based lobbying group that <u>ONLY</u> focuses on pro-life issues impacting the unborn! And welcome back everyone else!

I am pleased to report that, thanks to your e-mails and phone calls, Senate Bill 404 (Parental Consent for Abortion) narrowly passed the Florida Senate Judiciary Committee in a 3-to-2 vote last Wednesday. Now, the bill is in its final committee stop – and we have some more work to do.

The Florida Senate Rules Committee will hear SB 404 tomorrow, Wednesday, January 22, 2020, on the 47th tragic anniversary of *Roe v. Wade* and *Doe v. Bolton* – the two U.S Supreme Court decisions that together legalized abortion on demand nationwide.

The Rules Committee will meet early, from 8:30 a.m. to 10:00 a.m. in the Toni Jennings Committee Room, 110 Senate Building, at the Capitol.

We need to keep the pro-life pressure on, because pro-abortion forces are aiming to throw-up as many roadblocks as possible to delay this bill. The senators that sit on this committee need to hear from you TODAY! Their contact info is below. When you e-mail and call them, be sure to tell them that you're with Florida Voice for the Unborn and that you want SB 404 passed out of committee because it is a commonsense bill that helps to protect unborn children by affording a minor girl's parents the opportunity to stop an abortion of their grandchild. Like we did last week, let's keep the message short and simple – and keep the focus on the right to life of the unborn child!

If you are in the Tallahassee area Wednesday morning, please join me at the committee hearing and reply to this e-mail so that we can meet-up beforehand. Members of the public are usually given two minutes each to speak before the committee. I would encourage you to come about a half-hour to 45 minutes early. If you've never met me, see my picture below. I will be wearing a name badge and distributing "Florida Voice for the Unborn" stickers. We need as many pro-lifers as possible to speak out in favor of the bill during this last committee stop!
