

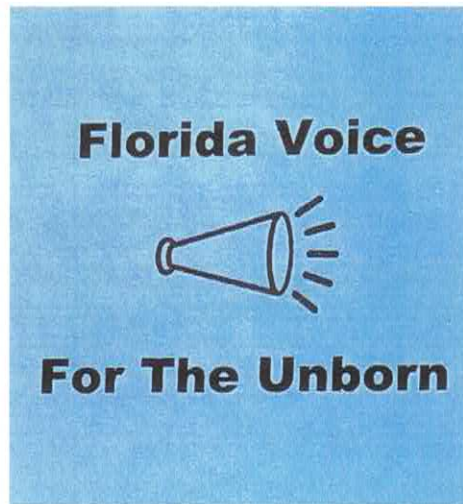
IMMEDIATE ACTION ALERT: Parental Consent for Abortion!

Dear Friend of the Unborn,

Last Thursday, February 6th, the Florida Senate passed Senate Bill 404 (Parental Consent for Abortion), with all 23 Republican senators voting in favor – and all 17 Democratic senators voting against the bill. This major accomplishment came after YOUR phone calls and e-mails made sure that the bill passed through two crucial Senate committees to get to the floor. Do not forget that last year, this same legislation died in those two same Senate committees!

The companion legislation, House Bill 265, now needs to be passed by the Florida House of Representatives. Although we do not yet know the date and time that the vote will occur, it is certain that it will take place very soon (perhaps later this week!).

We need to keep the pro-life pressure on, because Planned Parenthood and its allies are once again aiming to throw-up as many roadblocks as possible to

obstruct this commonsense legislation.

Unlike in the Senate, there are two pro-life House Democrats who have pledged to vote for the parental-consent bill: Rep. Kim Daniels (District 14 – Duval County) and Rep. James Bush III (District 109 – Miami-Dade County). Rep. Daniels is, in fact, a co-sponsor. There are also some House Republicans who have either voted against pro-life legislation in the past or who have yet to take a position on this bill.

Accordingly, Florida Voice for the Unborn has identified 5 key House members that we would like to see vote “yes” on House Bill 265 (Parental Consent for Abortion). Their contact info is further below. Please call and e-mail them right away! It does not matter if they represent your district or not – they will be voting on statewide legislation and must answer to the people of Florida. Planned Parenthood will consider it a “win” if it can intimidate these legislators into voting against the bill. We’re not going to let that happen!

This is the brief message that we want to convey: House Bill (HB) 265 has bipartisan support because polls consistently show that a great majority of Floridians believe that parents should be involved in a minor child’s life-altering decisions. Abortion is life-ending for the unborn child and life-altering for the minor – parents need to be involved so that they can have the opportunity to save their unborn grandchild and spare their daughter the pain and regret of having an abortion.
