

Florida Voice for the Unborn Praises the Florida House of Representatives for Passing Parental-Consent-for-Abortion Legislation

Executive Director Andrew Shirvell today issued the following statement regarding the favorable vote in the Florida House of Representatives:

“Florida Voice for the Unborn thanks the Florida House of Representatives for passing life-saving legislation that requires parental consent prior to a minor child obtaining an abortion in the state of Florida and enhances protections for babies born alive after failed abortions. Republican state Representative Erin Grall, who sponsored the House legislation, is a true pro-life champion and her leadership on this important issue is highly commendable.”

Shirvell continued, “The fact is, polls have consistently demonstrated that there is widespread bi-partisan support among the citizens of Florida for the involvement of parents in their minor child’s life-altering decisions. Clearly, parents are the ones who need to be involved – not the bloody merchants of death at Planned Parenthood! The legislation passed today will allow parents to help their minor daughter choose life when faced with an unexpected pregnancy.”

Shirvell further remarked, “Several Democratic state representatives joined all but two Republicans in voting for this commonsense, life-saving legislation. Due in part to strong lobbying by Florida Voice for the Unborn, Democratic Rep. Al Jacquet (District 88 – Palm Beach County) voted in favor of parental consent for abortion today even though in 2019 he voted against it. Meanwhile, Republican Rep. Heather Fitzenhagen (District 78 – Lee County) and Republican Rep. Holly Raschein (District 120 – Monroe and Miami-Dade Counties) once again showed themselves to be nothing more than Planned Parenthood sock puppets by voting against parental consent for abortion. It is a very good thing that both so-called Republicans are term-limited and will be exiting the Florida Legislature at the end of this year.”

Shirvell concluded, “Now that both the Florida Senate and House of Representatives have voted overwhelmingly for parental consent for abortion, Governor Ron DeSantis must swiftly sign this legislation into law. Unwarranted delays are unacceptable, as unborn children’s lives are at stake.”
