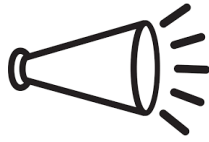

Florida Voice for the Unborn Requests That Attorney General Ashley Moody Immediately Issue a Cease and Desist Order to All Florida Abortion Facilities

Executive Director Andrew Shirvell today issued the following statement:

“I sent a formal letter today to state Attorney General Ashley Moody, requesting that she issue an immediate cease and desist order to all Florida abortion facilities in order to bring them into compliance with Governor Ron DeSantis’ Executive Order 20-72, filed March 20, 2020. Additionally, Florida Voice for the Unborn has begun a grassroots e-mail campaign directed at Attorney General Moody, reiterating that these places of death need to be closed today.”

Shirvell continued, “The governor’s executive order prohibits all elective medical procedures during the coronavirus emergency so that precious medical resources can be conserved. Surgical abortions, as well as chemical abortions, are clearly elective procedures. Therefore, under Executive Order 20-72, Florida abortion facilities are now prohibited from offering, performing, or advertising abortions.”

Shirvell further remarked, “Unfortunately, abortions have continued throughout Florida because Executive Order 20-72 is not being enforced! In both Texas and Ohio, the governors issued similar executive orders to that of Executive Order 20-72. When abortion facilities in those states failed to comply, the Texas and Ohio Attorneys General got involved. While the abortion facilities in Ohio appear to still be fighting the closure order, the Texas Attorney General has been much more successful in stopping abortions because he took decisive action by pledging to bring criminal charges against abortionists and their employees.”

Shirvell concluded, “Florida Attorney General Moody must follow the example set by her colleagues in Ohio and Texas. She must immediately order the closure of all abortion facilities throughout Florida. The longer she delays enforcement, the longer abortionists have to murder defenseless unborn babies. It is long past time for the Florida abortion industry to comply with
