

<u>Florida Voice for the Unborn Will Hold a Grassroots DAY OF ACTION at the State</u> Capitol in Tallahassee on Tuesday, May 24, 2022, During a Special Legislative Session

Executive Director Andrew Shirvell today issued the following statement:

"Florida Voice for the Unborn will be hosting a DAY OF ACTION at the Florida state Capitol complex on Tuesday, May 24, 2022. Grassroots pro-life activists from all over Florida are expected to be in attendance. The theme for this lobby day is: Abolish Abortion in Florida FOREVER! \*\*No More Excuses\*\*"

Shirvell continued, "On April 26th, Governor Ron DeSantis proclaimed a Special Legislative Session to address property insurance matters. That Special Legislative Session began today, May 23rd, and is expected to wrap-up by the end of this week."

Shirvell further remarked, "After a copy of the draft majority opinion in *Dobbs v. Jackson Women's Health Organization* was leaked, **Florida Voice for the Unborn** immediately sprang into action by issuing a letter to Governor DeSantis on May 3rd, requesting that the Governor authorize amending the agenda for this week's Special Legislative Session to include the consideration of legislation that would prohibit all abortions in Florida, from the moment of conception onward. **Florida Voice for the Unborn** made this urgent request because the draft *Dobbs* decision shows that the United States Supreme Court is poised to overturn *Roe v. Wade*, thereby returning to Florida and her sister states the rightful authority to once again completely prohibit abortion."

Shirvell continued, "Florida Voice for the Unborn's DAY OF ACTION will commence with an outdoor rally, from 11:00 a.m. to ~11:45 a.m., on the stairs of the Historic Capitol (facing the modern-day Capitol building). Featured speakers at the rally include Representative Webster Barnaby (R–District 27, Volusia County); Representative Randy Fine (R–District 53, Brevard County); Representative Anthony Sabatini (R–District 32, Lake County); Representative Joe Harding (R–District 22, Levy and Marion Counties), and more! Members of the Governor's team are also expected to attend, and may speak as well."

Shirvell added, "Following the rally's conclusion, **Florida Voice for the Unborn's** supporters will move into the Capitol building to lobby key pro-life lawmakers and their staff at their Capitol offices."

Shirvell concluded, "Florida Voice for the Unborn's peaceful, law-abiding DAY OF ACTION will conclude with a press conference at 1:45 p.m. on the fourth-floor rotunda of the Capitol building. Members of the press are encouraged to cover our rally. However, journalists will not be permitted to accompany us as we lobby our lawmakers and their staff members at their offices. All members of the media are invited to our 1:45 p.m. press conference, at which I will issue a brief statement and take questions from the assembled journalists, while surrounded by Florida Voice for the Unborn's grassroots supporters!"
