

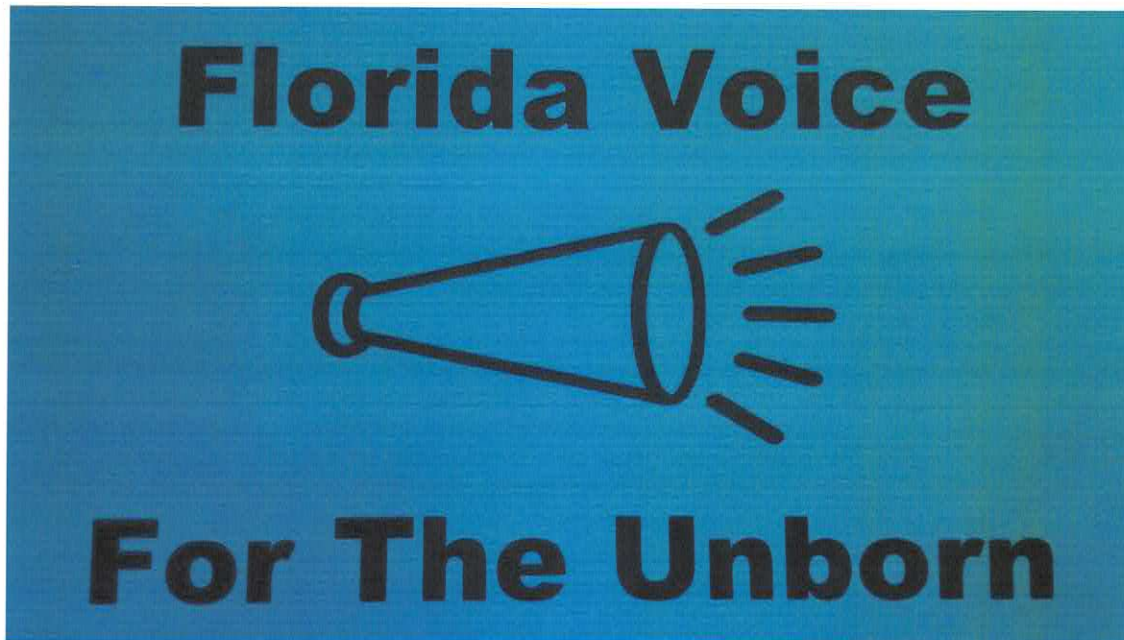
SB 698 VETO ACTION ALERT!

Dear Friend of the Unborn,

This is an urgent action alert regarding Senate Bill 698 (Reproductive Health), which passed both the Florida Senate and House of Representatives during the waning days of the annual Legislative Session.

This deeply-flawed bill, which offends the dignity of human life, will now be presented to pro-life Governor Ron DeSantis, who can choose to sign it into law, veto it, or take no further action which would then allow the bill to become law without his signature.
