

### Dear Friend of the Unborn:

I am going to be uncharacteristically brief because I've been swamped with media interviews since last night's bombshell leak of the draft majority opinion in *Dobbs v. Jackson Women's Health Organization*.

As you probably know by now, this draft opinion shows that the United States Supreme Court is poised to overturn *Roe v. Wade*, thereby returning to Florida and her sister states the rightful authority to once again completely prohibit abortion within their borders.

Therefore, this is our most important Grassroots Action Alert ever because there is a Special Legislative Session in Tallahassee scheduled for the week of May 23rd!

This morning, I wrote a letter (on behalf of Florida Voice for the Unborn) to Governor DeSantis and his key advisors, requesting that he amend his original April 26th Special Legislative Session proclamation, so that additional pro-life legislation can be considered!
