The placement of responsibility under any specific column does not necessarily coincide with the actual ownership of the component. The Unit deed determines ownership. In some cases, maintenance responsibility may be allocated to the Association to ensure consistency, uniformity and quality of repair and to protect community health and safety. In other cases, the Executive Board is able to determine whether maintenance is performed by a Unit Owner or the Association. Where maintenance, repair or replacement is required due to the negligent or wrongful act or omission of a Unit Owner (or such Unit Owner's family, tenants, employees, agents, visitors, guests or pets), the Association will perform the necessary maintenance at the sole expense of the Unit Owner. Capitalized terms used but not defined in this Exhibit shall have the meaning(s) given to such term(s) in the Declaration, Rules and Regulations, and Bylaws.
