The Service is designed for professional carers, care groups, nursing homes, hospices, memorial service and families using the videos for non-commercial care purposes.

## **3. Our Services**

We produce tailored video experiences using content provided by the customer (photos, messages, music preferences, etc.).

Our content is created for sensory engagement, reminiscence, and wellbeing — not for diagnosis, therapy, or clinical treatment.

Turnaround times and delivery methods are outlined at point of purchase. Delays caused by incomplete submissions are not our responsibility.

## **4. Subscriptions and Billing**

Certain services may be offered on a subscription basis (e.g. monthly or annual packages for care groups).

Subscriptions auto-renew unless cancelled at least 7 days before the next billing cycle.

You can manage your subscription and billing via your Remconex account or by contacting us. Prices may change with notice. Continued use after changes constitutes acceptance of the new pricing.

## **5. Care Group Licensing**

Care homes, hospices, and professional organisations may purchase group access licences for shared use among staff or residents.

Group licences do **not** grant rights to redistribute videos outside the organisation or to third parties. Each licence is subject to the terms agreed at the time of subscription or purchase.

## **6. Intellectual Property**

All original content produced by Remconex Ltd (including videos, audio, visuals, and branding) is owned by us.

You are granted a limited, non-exclusive, non-transferable licence to use the content for personal or care-setting use.

Redistribution, resale, or public broadcast of our content without written permission is strictly prohibited.

## **7. User Content and Rights**

You retain ownership of the content you provide to us.

By submitting any content, you grant us a non-exclusive right to use, adapt, and incorporate it solely for creating your video.

You are responsible for ensuring that you have the legal rights and permissions for all content you provide.

## **8. Refund Policy**

Due to the personalised nature of our videos, refunds are not provided once production has begun. If there is a fault with the final product caused by us, we will offer a revision or refund at our discretion.
