

**Assumption of the Risk, Waiver of Liability and Covenant Not to Sue**

**NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in entirety. By signing this agreement, you give up your right and the named minor's right to bring a court action to recover compensation or obtain any other remedy for any personal injury, illness, or property damage however caused arising out of the named minor's participation in any our programs, now or any time in the future.**

**Acknowledgement of Risk.** I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge, and agree that participation in activities conducted by, sponsored by or located at **Strung-Out LLC dba Bull Shark Sports, Briarcliff Woods Beach Club and/or Lindmoor Woods Recreation Center**, and each of its subsidiaries and affiliates, and each of its past or present owners, officers, directors, members, managers, employees, contractors, supervisors, agents, or representatives and assigns (collectively known as "Bull Shark Sports") comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with these activities (collectively, the "Program") participation, including but in no way limited to: (1) slips, trips, and falls, (2) athletic injuries, and (3) illness, including exposure to viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with Program participation and that said list in no way limits the operation of this Agreement.

**Consent to Medical Treatment.** By signing this form, I hereby give permission to Bull Shark Sports to hospitalize, or secure proper treatment for, my child. I hereby FOREVER release, discharge, indemnify, hold harmless, defend, exonerate, and covenant not to sue Bull Shark Sports from any and all liability or claim whatsoever which arises or may hereafter arise, directly or indirectly, on account of any first aid, treatment, or medical service rendered in connection with the Program activities participated in by my minor child with Bull Shark Sports, and I assume all risk associated therewith. I also understand that Bull Shark Sports does not and shall not assume any responsibility for or obligation to provide financial assistance or other assistance to me or to my minor child (if applicable), including, but not limited to, medical, health, or disability insurance in the event of injury, illness, or other claim or loss.

**Waiver, Release, Indemnification and Covenant Not to Sue.** In consideration of the participation of the undersigned named minor in Bull Shark Sports activities, the parent/guardian of the minor named below agrees to release and on behalf of myself and the minor named below, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE, Bull Shark Sports, its owners, officers, directors, employees, volunteers, agents, contractors, representatives and insurers ("Releasees") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, together with the named minor, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Bull Shark Sports on account of personal injury, property damage, illness, death or accident of any kind, arising out of or in any way related to the participation in the Program activities or other activities whether that participation is supervised or unsupervised, however the injury, illness, or damage occurs. In consideration of the named minor's participation in Program activities, I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's Program participation.

**Policy on Photography.** I authorize and grant permission for the use and reproduction of any and all photographs or video footage of myself or my dependents for any lawful purpose including Bull Shark Sports promotional purposes without compensation.

**Licensing Disclosure.** I understand that the Bull Shark Sports day camp program is not licensed and is not required to be licensed by the State.

**ACKNOWLEDGEMENT:** By signing below, I acknowledge that I am at least 18 years of age, legally competent to sign this agreement and have legal capacity to act as the parent/guardian of the named minor. I further acknowledge that I have read the above information, and that I understand the policies and guidelines of the program and I agree to abide by them.
