Nominations for the following Local 15 elected offices will be accepted from the floor at the May 2026 joint membership meeting to be held on **Thursday, May 7, 2026, at 6:00 p.m. ET** at the Local 15 Training Center, Lefferts Boulevard, South Ozone Park, NY: Business Manager; President; Vice President; Recording-Corresponding Secretary; Financial Secretary; Treasurer; Auditors (3); Trustees (3); Guard; and Lay Members of the Executive Board (4). **Kindly note that, as always, the entrance gates to the Training Center will close at 5:30 p.m. ET sharp, and no one will be permitted to enter the premises after that time.**

All nominations must be properly seconded from the floor in order to be valid and effective. Additionally, all prospective candidates for office must comply with the Nominating Petition requirements contained in Article II, Section 2, Subsection (d) of the Local 15 Bylaws and Article XXIV, Subdivision 1, Section (b) of the IUOE Constitution, along with any and all other eligibility requirements as contained in the Local 15 Bylaws and the IUOE Constitution. Detailed information and instructions about picking up, completing, and submitting Nominating Petitions, including submission deadlines, will be **posted on the Local 15 website on April 6, 2026**. Prospective candidates may also call the Local 15 Union office at 212-929-5327 to obtain information about the process of picking up, completing and submitting Nominating Petitions.

In accordance with the Local 15 Bylaws, the Business Manager, President, Vice President, Recording-Corresponding-Secretary, Financial Secretary, and Treasurer shall be delegates to, and attend, any General Convention held during their terms of office. The term of all elected offices will run for three (3) years commencing on September 1, 2026, in accordance with the applicable provisions of the IUOE Constitution.

Finally, please be advised that, at the close of the nominations process, additional business of this joint membership meeting will also include motions and allocation votes from the floor by the membership on the increments due on July 1, 2026.
