Hampshire Fire Protection District 2023 Final Report From The Fire Chief





It was a busy year for the fire district, we responded to 1,563 calls for service. That made it the second busiest year in department history just short of last year's record of 1,578 calls for service. We finalized the plans for fire station 2 and we broke ground on August 2nd. The station is scheduled to be completed in late spring of 2024. With the Tamms Subdivision about complete, the Prairie Ridge Subdivision expanding north of Kelley Road, the commercial development occurring in the Rt. 20 and I-90 area and the planned Oakstead Subdivision off of Big Timber Road, the timing for station 2 couldn't have been better planned.

We hired three full-time and six part time firefighters during the year. We now have 12 full-time and 24 part-time firefighters. With the additional firefighters, we were able to staff the station with 6-7 firefighters per shift on a regular basis. This allowed us to staff three units frequently enabling us to handle more multiple calls in progress in which we had 322 multiple calls in progress in 2023, that was the most ever in department history.

Unfortunately, in July we had a serious accident with our primary fire engine when it left the road and rolled over. We are so thankful that the four firefighters in the engine only sustained minor injuries. Shortly after that accident our Deputy Chief while responding to an accident on the tollway was struck from behind at high speed by another vehicle. Thankfully he only sustained minor injuries. Our drivers training committee reviewed our driver's training policy and made some minor changes in hopes we limit the chances of an accident occurring again. A new fire engine and staff vehicle will be delivered in 2024.

In this report, you will review many statistics from incidents, training, public education and fire prevention and all of the other services and programs we completed during the year. There were numerous administrative and operational accomplishments as well as we continue to strive to provide the best services possible to our residents. I am extremely proud of my administrative staff and firefighters for the work they do daily. We look forward to continuing to enhance those services in 2024.




Jenny Misner Full-Time Firefighter / Paramedic







2023 Summary

- 1. The Hampshire Fire Department responded to 1,563 incidents in 2023. There were 1,017 ambulance requests and 546 fire requests. Personnel spent 1,690 hours and 5,857 Man Hours on incidents during the year.
- 2. There were 1,508 still alarms, 31 full-still alarms / department recalls and 24 general alarms.
- 3. 880 patients were treated during the year with 425 receiving Advanced Life Support Treatment and 395 receiving Basic Life Support Treatment. There were 60 mutual aid patient assists.
- 4. There were 92 vehicle accidents with 148 patients, 29 ALS patients, 119 BLS patients, 3 fatalities and 12 accidents required extrication.
- 5. The total property fire loss for the year: (\$745,506.00) Property value: \$14,019,484.00
- 6. 718 incidents occurred in District 11, 98 incidents occurred in District 12, 165 incidents occurred in District 21, 106 incidents occurred in District 22, 45 incidents occurred in District 23 and there were 431 mutual aid /auto aid requests.
- 7. There were 447 EMS responses in District 11 with an average response time of 3:44.
- 8. There were 140 Fire responses in District 11 with an average response time of 3:41.
- 9. There were 7 EMS responses in District 11 for a cardiac arrest with an average response time of 4:13.
- 10. There were 8 responses in District 11 for a structure/equipment fire with an average response time of 3:08.
- 11. There were 8 responses in District 11 for a vehicle accident with an average response time of 3:36.
- 12. There were 52 EMS responses in District 12 with an average response time of 6:02.
- 13. There were 19 Fire responses in District 12 with an average response time of 6:38.

- 14. There was 1 response in District 12 for a cardiac arrest with an average response time of 6:19.
- 15. There were 0 response in District 12 for a structure / equipment / content fire with an average response time of 0:00.
- 16. There were 21 responses in District 12 for vehicle accidents with an average response time of 8:11.
- 17. There were 72 EMS responses in District 21 with an average response time of 8:50.
- 18. There were 48 Fire responses in District 21 with an average response time of 8:59.
- 19. There were 2 EMS responses in District 21 for a cardiac arrest with an average response time of 7:55.
- 20. There were 3 responses in District 21 for a structure / equipment / contents fire with an average response time of 8:44.
- 21. There were 7 responses in District 21 for vehicle accidents with an average response time of 8:11.
- 22. There were 44 EMS responses in District 22 with an average response time of 6:50.
- 23. There were 26 Fire responses in District 22 with an average response time of 9:02.
- 24. There was 0 EMS response in District 22 for a cardiac arrest with an average response time of 0:00.
- 25. There were 2 responses in District 22 for a structure / equipment / contents fire with an average response time of 7:58.
- 26. There were 30 responses in District 22 for vehicle accidents with an average response time of 7:19.
- 27. There were 10 EMS responses in District 23 with an average response time of 14:02.
- 28. There were 6 Fire responses in District 23 with an average response time of 14:01.

- 29. There were 25 responses in District 23 for vehicle accidents with an average response time of 12:55.
- 30. There were 2 responses in District 23 for a Cardiac Arrest with a response time of 13:10.
- 31. There were 54 Auto aid / mutual aid fire responses with an average response time of 16:39.
- 32. There were 136 Auto aid / mutual aid EMS responses with an average response time of 9:29.
- 33. The Department responded to 376 non-emergency/other calls for the year.
- 34. There were 17 EMS Walk into the fire station during the year.
- 35. We received EMS mutual aid 90 times with 43 transports.
- 36. We responded EMS mutual aid 74 times with 29 transports.
- 37. Engine 1411, Ambulance 1453, were the busiest units responding to 505 and 578 incidents respectively.
- 38. Department personnel completed 13,399 training hours during the year.
- 39. Department personnel completed 1,821 fitness hours during the year.
- 40. The department responded to 80 fires: (38 structure, 19 brush, 13 vehicle, 7 equipment, 3 other type)
- 41. 152 Public Education / Relation programs were conducted totaling 173 hours (640 -man hours) with 19,463 people attending the programs.
- 42. The busiest time of day was between 17:00 18:00 with 108 calls.
- 43. 2023 average calls per day: 4.28
- 44. 2023 average calls per month: 130.25
- 45. The busiest day of the week was Wednesday with 274 calls.
- 46. There were 322 times that the department had multiple calls in progress.
- 47. Gold shift was the busiest shift with 548 calls.

- 48. Black and Red shift had the best out the door time during the day with an average of 1:08 (331) & (349), Red shift at night with 1:37 (94).
- 49. There was a total of 55 Department Recalls during the year with an average of 1 firefighter coming back per callback.
- 50. Shift personnel spent 2,017 hours on apparatus inspections /maintenance/inventories/washing, station housekeeping/maintenance, and administrative duties and projects.
- 51. 311 fire inspections were conducted with 306 violations being found. There were 238 re-inspections conducted with 324 violations corrected. 1,060 hours were spent on inspections and Bureau work during the year. We billed \$ 20,451 in plan reviews for the year.
- 52. Building Permit report: 286 new residential permits and 4 new commercial permits were issued during the year.
- 53. 2023 Incidents: 1,563 2022 Incidents: 1,578






6 Year Call Volume






Calls By Shift



Turnout Times








Average Emergency Response Times By District






2023 Calls By Month



Calls By Day of the Week




Medical Call By Type







Cardiac Arrest Responses











2023 Fire Dollar Loss




Structure Fire Responses








Total Hours by Method of Instruction

We enhanced our officer's development program continuing with monthly homework assignments and meeting once a month to conduct hands on practical's.

FF Misner enhanced our residential smoke detector program catering to senior citizens. FF Misner performed numerous residential smoke detector inspections with the new program.

We completed an agreement with the Jr. Whips Football Program for EMS Standby at all home games and the fire district is paid for its services.

FF Serrano installed 35 new fire hydrant flags.

An Intergovernmental agreement was completed with the Village of Hampshire for the fire district to conduct all fire protection system plan reviews and collect the review fees.

FF Morgan installed 128 new fire number signs.

FF Morgan installed address/9-1-1 signs in every park entrance (Seyller, Schmidt, Ream, Tennis Courts, Rackow).

We completed the Decennial Committee Report, this was a 33-page report covering all aspects of the district and its overall efficiencies. The report was submitted to the Kane and DeKalb County Boards.

Sikich conducted our annual budgetary audit and reviewed it with the board and we received a good report (Remakel).

The Rt. 72 /State Street pre-emption light project was completed.

Captain Stadie coordinated rescue task force and active shooter training with the Police Department.

We completed the Illinois Fire Protection District Annual Checklist completing 95% of the requirements.

DC Larson completed the Illinois State Fire Marshal audit.

We completed the (IPRF) Illinois Public Risk Fund annual review and had a good report.

All fire hydrants were flushed and the data was entered into our reporting system.

We finalized standard operating guidelines for structure fires for Hampshire, Burlington and Pingree Grove and they will be implemented in 2024.

We completed a table top disaster exercise involving a gas explosion.

New reporting software (ESO) was purchased and it will be fully implemented in 2024. The software will include; emergency response, scheduling, fire inspections, maintenance, etc.

FF Ramirez continued with the firefighter bunker gear replacement program for NFPA compliancy.

FF Ramirez and FF Black continued as members of the Division 2 Technical Rescue Team.

Lt. Rice and FF Morgan continued as members of the Division 2 Hazardous Material Team.

Lt. DePauw continued as a member of the Division 2 Dive Team.

Lt. McBride, FF Clauss and FI Lucas continued as members of the Kane County Task Force Investigation Team.

We began discussions to form a Hampshire, Burlington, and Pingree Grove Fire Investigation Team that will be implemented in 2024.

Our EMS Billing rates were adjusted to coincide with the annual GEMT evaluation.

All personnel had their annual physicals.

Firefighter Laura Black finalized the Firefighter Internship Program Booklet.
