

Table and Chair Rental Agreement

Agreement made on ___/___/___, between _____, with their primary address at _____ hereinafter referred to as "Renter," and Hampshire Fire/EMS Association, with their primary address at 202 Washington Ave Hampshire IL 60140, hereinafter referred to as "Rental Company."

1. Equipment Rental

Rental Company agrees to lease to Renter the following equipment (hereinafter referred to as "Equipment"): #___ tables and #___ chairs.

2. Rental Period

The rental period begins on ___/___/___ and ends on ___/___/___ . The rental length is not to exceed 7 days from pick up date.

3. Rental Fees

Renter agrees to pay Rental Company a rental fee of \$_____ for the Equipment rental. The tables will be \$10 each and the chairs \$2 each for the duration of the rental agreement. The rental fee shall be paid in full upfront before the Equipment is used by the Renter. At the end of the Term or upon earlier termination of this Agreement, the Lessee will return the Equipment to 202 Washington Ave Hampshire IL, 60140 within the designated operating hours. If the Lessee fails to return the Equipment at the end of the Term or any earlier termination of this Agreement, the Lessee will pay to the Lessor the Casualty Value of the Equipment of \$100.00 per table and \$30.00 per chair at which point ownership of the Equipment will pass to the Lessee.

4. Pick-up and Drop-off

Pick-up and Drop-off times are available during the following times:

Monday – Saturday 8am to 5pm.

Rentals are not to be picked up or returned on Sundays.

5. Equipment Condition

The Equipment shall be delivered to Renter in good working condition. Renter shall use the Equipment only for its intended purposes and shall return the Equipment to Rental Company in the same condition as when received, except for ordinary wear and tear.

6. Indemnification

Renter acknowledges that they assume all risks of loss, damage, or injury to persons or property arising from the use of the Equipment by Renter or any other person to whom

Renter provides access to the Equipment. Renter agrees to indemnify and hold harmless Rental Company from any claims, damages, or expenses arising out of the use of the Equipment.

7. Termination

Either party may terminate this agreement at any time by giving written notice to the other party. Upon termination, Renter shall return the Equipment to Rental Company in good working condition.

8. Governing Law

This agreement shall be governed by and construed in accordance with the laws of the state of Illinois, and shall be binding upon the parties hereto and their respective heirs, successors, and assigns.

9. Entire Agreement

This agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral, relating to the Equipment rental.

10. Execution

This agreement shall be executed in duplicate copies, one of which shall be retained by Renter and one of which shall be retained by Rental Company.
