The Board's responsibility is to provide financial oversight and strategic planning to ensure the District's fiscal stability while providing the highest level of service possible to its residents. The board had a busy year with the opening of fire station 2, the appointment of a board of fire commissioners, the purchase of a new fire engine, remodel of fire station 1, the approval of Lieutenant promotions, a federal funding request for \$1,000,000 for the new station/new apparatus, finalizing a new union contract, and starting the process to hire a new fire chief.

The Board of Fire Commissioners (BOFC) was established in June. This board was required by state statute due to the number of full time firefighters on the department. The BOFC is responsible for the hiring, discipline, termination and promotions of all full time firefighters. The BOFC began the testing process for Lieutenant promotions and to establish an updated full time hiring eligibility list. Promtions and additional full time firefighter hirings are anticipated in 2025.

Financial Director Remakel completed the annual district audit with Sikich LLP where the district received a good financial review. She created a new time card system that saved the district money by not using an outside company. She applied for loans to assist the district with the purchase of new apparatus and to pay off station 2 construction. She assisted the fire chief with a federal funding request for \$1,000,000. She worked with local banks with CD's bringing in over 240,000 thousand dollars in interest to the district. She completed a 5-year budget projection. She trained Captain Stadie to begin assisting her with payroll, paying bills and doing the meeting agendas and minutes.

Fire Marshal Mark Clauss had a busy year. Over 300 occupancy life safety inspections were completed including all of our schools and apartment buildings. He regularly checked to assure there were no open flame grills on multifamily residential wooden balconies per the fire code. Numerous plan reviews were completed for new or renovated commercial occupancies and residential solar panel installations. We collected over \$9,000 dollars in plan reviews. He continued his education attending several classes and seminars. Fire Marshal Clauss worked with the Super 8 Motel to have a new fire alarm system installed as the existing system became antiquated and was generating numerous false alarms. He also conducted several building walk throughs with our firefighters to assure they were educated on building layout and construction, hazards, utilities, hydrants and fire protection systems.





2024 Line of Duty Deaths By State



2024 Summary

- 1. The Hampshire Fire Department responded to 1,798 incidents in 2024. There were 1,210 ambulance requests and 588 fire requests. Personnel spent 1,909 hours and 6,612 Man Hours on incidents during the year.

- 47. There was a total of 37 Department Recalls during the year with an average of 0.5 firefighters coming back per callback.

- 48. Shift personnel spent 1,317 hours on apparatus inspections /maintenance/inventories/washing, station housekeeping/maintenance, and other projects.
- 49. 343 fire inspections were conducted with 212 violations being found. There were 160 re-inspections conducted with 201 violations corrected. 903 hours were spent on inspections and Bureau work during the year. We billed over \$9,000 in plan reviews for the year.
- 50. Building Permit report: 166 new residential permits and 4 new commercial permits were issued during the year.



















Average Emergency Response Times By District





(Red=Number of responses, Orange=Average Response Time, Gray=Civilian Injuries)






2024 Calls By Month






Calls By Day of the Week




Calls By Time Of Day





Special Operation



On Friday January 12th the area was hit with a winter storm that would have significantly increased our response times to our northern district including the tollway. Through an agreement we had finalized with the Illinois Tollway in 2022 we were able to staff Brush Truck 1438 with BLS capabilities, fire suppression and extrication equipment at the M6 Building at Rt. 20 and I-90. Firefighters Josh Morgan and Tyler Ribandt staffed the vehicle. We responded to several accidents on I-90 with a response time of less than 5 minutes which made a significant difference. This was the second time we had implemented the agreement since its existence. With the opening of station 2 in May, it's unlikely we will have to use the agreement in the future.

Large Group Gathering Safety Committee



For any large group outdoor gathering event scheduled within the village a safety committee meets with the responsible party of the event. The committee is made up of personnel from the Police Department Command Staff, Fire Protection District Command Staff and Public Works Department Director. The committee discusses all safety aspects to include inclement weather, evacuation, emergency contacts, road closures, traffic flow and emergency access and response.

EMS Captain Stadie reviews our emergency response plan with the shift that the event falls on. The response plan includes command post location, access, triage, treatment and transportation areas.




We collected for Toys for Tots and the Homeless and had an incredible turnout of people who donated lots of toys, sleeping bags and blankets!

Smoke Detector Program





Fire Station 2 was completed in May of 2024 and we began staffing it on May 23rd at 8:45 a.m. The final cost came in at \$5,400,000, which was about \$200,000 under budget.





Company Citation Incident Number 23-1051 On Monday September 3rd, 2023 at 17:37 hours we were dispatched for an accident at Rt. 72 and Walker Road. On arrival it was a two-vehicle accident with heavy damage with one vehicle rolled over on its side with 2 patients trapped in the vehicle. One patient was pronounced deceased, the other patient was partially trapped under the vehicle and went unconscious and was seizing. The vehicle was extremely unstable as it lied between two pine trees with no good way to stabilize it. The vehicle was also leaking gasoline. Firefighters worked diligently and tirelessly to stabilize the vehicle and extricate the victim using airbags and extrication tools. The patient's airway was maintained during extrication but due to the patient's location, no other intervention could be done. The vehicle had to be stabilized and then lifted with airbags and then cut to remove the victim from underneath, this was extremely challenging. The patient was extricated in 53 minutes, was treated and then flown out by helicopter with critical injuries. A third patient was transported with non-life-threatening injuries. Pingree Grove, Burlington and Genoa Kingston Fire Protection Districts assisted. Company Citations were awarded to:

Company Citation Incident Number 23-1556 On Saturday December 30th, 2023 at 18:43 hours we received a phone call at the fire station reporting a vehicle accident on I-90. Lt. Rice and the company began responding and advised Kanecom to dispatch the accident. On arrival it was a 6-vehicle accident with heavy damage with one vehicle on its roof and fully involved in fire. The vehicles were quite spread out with one vehicle down a steep embankment with a patient still in the vehicle. There were numerous bystanders which made it challenging to sort through who was involved and who was not. In total there were 11 patients in which 9 were transported to 3 area hospitals. One patient had serious injuries all other patients had moderate to minor injuries. This was classified as a mass casualty incident and an EMS Branch was established to include Incident Command, Medical Branch, Triage/Treatment, Transportation, fire suppression and Operations. A 2nd Alarm EMS Box was activated bringing in 10 additional fire departments.

FF Chris Blonskij who was a brand-new paramedic was assigned to medical branch officer and did an outstanding job! Pingree Grove Ambulance was assigned to triage/treatment, Chief Howell was assigned to Operations and Chief Tiedt was Staging Officer and had to get ambulances in and out which is never easy on the tollway with traffic back up, lane blockage and limited turn arounds. Lt. Rice was fire suppression and a foam operation had to be set up due to the gas tank rupturing on the vehicle fire. Incidents of this magnitude can become chaotic quickly but this incident was extremely efficient and as I had stated in a letter to the Sherman Hospital Medical Director, it was one of the smoothest mass casualty incidents I have been on and I have been on quite a few in my 35 years. Gold Shift 100 Club Valor Award and a Pingree Grove Citation Award for Incident Number 23-1273 On October 23rd 2023 at 7:06 a.m. we responded auto aid to Pingree Grove for a two-vehicle head on accident with heavy damage and entrapment on Rt. 47 south of Plank Road. Engine 1413 and Ambulance 1453 responded and assisted Pingree Grove with extrication and patient care. The patient that was extricated was a Kane County Sheriff Detective. The extrication was lengthy due to the extensive damage. The patient was treated and flown out by helicopter with critical injuries. The detective is currently recovering from his injuries. The Pingree Grove Fire Protection District received the St. Joseph Hospital Call of the Month. KC Sheriff Ron Hain nominated Pingree Grove and Hampshire Firefighters for the 100 Club Medal of Valor Award where they received the award in February. Hampshire Personnel receiving the award were:




Incident Number 23-873 On July 24th 2023 at 16:08 hours we were dispatched for a still alarm for a grill on fire on the deck in the 800 Block of Elm Street. While enroute a large column of Black smoke was visible from several blocks away. The alarm was immediately upgraded to a general alarm for a working structure fire. On arrival it was a large two-story residential structure with heavy fire in the rear balcony with heavy fire extension into the attic space and fire extension into the kitchen. A hose line was stretched to the rear and put into operation. Shortly after that, we were informed that someone was trapped in the home. Lt. Rice, FF Blonskij, and FF Mayfield immediately began a search of the second floor with heavy fire above them, no hose line and zero visibility. FF Connor Sardo remained on the hose line penetrating the soffit and keeping the fire in check until lines could be advanced into the structure. We had no other companies available at this point; the second floor was searched and no victim was found, it was then determined that the wife had exited the front and the husband exited out the back and they did not know where the other was at. The husband lay in the far back corner of the yard with second degree burns on a portion of his body. He was treated and transported to a hospital and made a full recovery. Two hose lines were advanced into the home and the fire was brought under control in about 45 minutes, containing the fire to the attic, deck and kitchen. This is a reminder of the chances we take and again a job well done and a tribute to our training.

He is our first ever bilingual CPR Instructor, and has been a great asset to our CPR program as he teaches bilingual employees at many Hampshire Businesses. He is always doing hands on training no matter which shift he works. He is always willing to help no matter what and he does it without complaining. He recently completed Hazardous Material Technician Training. He has been a great asset to this department! He has taken on our fire hydrant flag program and he is in charge of all fire hose. He actually went out and tested fire hose by himself during hose testing last fall.

Dear Chief Herrmann,

On the morning of November 7th, 2024, I was just about to get ready for work when I experienced a pain in my chest that I had never felt before. When it did not subside immediately, I knew that there was something wrong. All I could do was lay down in the hallway and wait for my daughter to call 9-1-1.

The first crew from Hampshire arrived very quickly and began their assessment. I heard the words "I have elevation in V2, V3, V4, V5." My initial suspicions were all but confirmed at this point. My only thought was this is going to be bad.

Additional members of the fire department arrived and continued their work. Every member was compassionate and professional. They calmly and quickly delivered initial medical care and transported me to Sherman Hospital. Along the way, they kept me informed of everything that they were doing and made me as comfortable as possible given the situation. I can not even describe the calm I felt while being treated by your team.

Even after handing me off to the Emergency Department staff, the crew made sure to check in with my family and keep them informed. In the end, I ended up with a stent in the left coronary artery due to 100% blockage of the mid widow maker.

I know that you are extremely proud of your department members, and I can see why. I've witnessed them in the community, on incidents and in my own care, so I know the professionalism they display and the care they deliver firsthand.

I can truly say that I am alive today due to the treatment and initial care that I received from the Hampshire Fire Protection District. From the bottom of my still working heart, I am ever grateful to the crew that saved my life.

Please extend my gratitude to all of them. I can not thank them enough for what they did for me.


