Appendix A

Club Name & Registration

The name shall be Wessex Racing Club. Wessex Racing club is a registered Racing Club with BHA/Weatherbys and has its own dedicated Weatherbys Bank Account for Wessex Racing Club transactions only.

The managers of the club shall be Jeremy Barber and Jeremy Blackburn with administrative support from Lucy Blackburn. These are the only persons responsible for liaising with the BHA/Weatherbys. Only the managers need to liaise with the BHA or Weatherby's regarding Wessex Racing Club.

Membership

Membership is effective for a period of 12 months from whatever date the Member joins. If the Member chooses not to renew at the end of the 12 months period, the membership shall expire.

We will initially have 2 horses in training with the intention of putting more horses into training as the membership numbers increase. If our club horse(s) is injured, then it is the responsibility of the managers to find a replacement. Wessex Racing club will aim to have a minimum of 1 horse in training at any given time.

Please note that the 12-month membership fee is not subject to any additional requests for payment in relation to the keeping and training of the racehorses, no matter what costs the Club may incur.

Full "legal and equitable title" to The Club's horses remain at all times with The Club, at no time does a Member have a legal or another interest in any of the horses referred, or indeed any share of.

Badges to the racecourse when your horses run will be available to club members. Racecourses often limit owner's badges to 6/8 per horse. Club members are invited to enter a draw to attend the race meeting with a complimentary owner's badge. On occasions there may be a chance to purchase owners badges, again this may be subject to a draw.

Club members are also welcome to buy general admission badges from the racecourses directly.

Membership fees

12 month membership fee of £1200 or £100 per month, whichever is preferable.

Membership fees will be £100 per month for the first 75 people who join, and then reduce to £90 per month, for everyone, when there are 76 members; reduce to £80 per month, for everyone, when there are 151 members; and to £70 per month, for everyone, when there are 251 or more members in The Club. Any refunds will be applied in a pay out on July 31st 2019.

The prize money issued to members will be broken down as follows:

Members 01-75 – 50%

Members 76-150 - 25%

Members 151-250 – 15%

Members 251 + - 10%

Prize money payments will be apportioned to the length of membership. Starting from August 1 2018 and then divisible by a 1/12 per month until pay-out on July 31st 2019.

For example, if a member joins in October 2018 they will get 9/12ths (3/4) of their percentage share or January 6/12ths (1/2). This recognises the commitment of those people who sign up early for the club.
