
Adrienne Westwood Projects VIA Collaborative Arts Corporation

This opportunity allowed Adrienne to deepen work with performers Amanda Kmett'Pendry, Kathryn Logan (also video dramaturg), Solana Hoffmann-Carter, Laura Witsken, and Katie Swords Thurman. Rebecca Fitton (performer and also the project's

audio describer) joined us virtually from Texas, where she is in graduate school. We welcomed Lilach Orenstein as production manager and also welcomed dancer Marissa Truitt, a recent graduate of University of North Carolina School of the Arts; she was a 2021-22 Kenan Fellow at Lincoln Center, and Adrienne had the pleasure of mentoring her through that program. (Some of you may remember Adrienne herself had this fellowship in 2003-04, the opportunity that served as impetus for co-founding VIA nearly two decades ago!)



Pending Grants and Opportunities

Our ultimate goal is to have more time creating in the studio and more opportunities to share this work with audiences. To that end, it has been a very full year of conversations with potential parters, continued relationship building, and a lot of grant writing. With the help of the generous staff at ODC Theater, we applied for a project grant from The National Endowment for the Arts for the first time. (We applied in July and will be notified in April -- it's a long process!)

Finalists

There are a few highly competitive opportunities that we were not awarded, but for which we did advance into final rounds. We want to celebrate that there is growing energy around our work. We look forward to building upon and deepening these relationships over the coming year!

- Over the summer [] advanced to the third and final application round for a highly competitive Hewlett 50 Commission, a proposal we were invited into by ODC Theater in San Francisco. Sadly we were not awarded the commission this year, but we know that being among the top 20 proposals considered (from over 100 applicants!) is something to celebrate.
- Adrienne and Angélica were among about 20 artists included, by invitation only, into conversation with The Chelsea Factory in Manhattan, where they were under consideration to be Artists in Residence for 2023.
- [] advanced through two rounds of consideration for a Dance in Process residency at Gibney Dance in Manhattan.
- Adrienne was a finalist, from over 140 applicants, for a New Jewish Culture Fellowship, to continue work on her intimate project box/truck.

Katie Swords Thurman


