The topic of digitizing scrapbooks was again brought to the floor. Clint Sundt stated that he took books 1 and 2 to get them digitized, emphasizing the importance of protecting this information for generations to come. During the discussion about digitizing books, Jim Constand took out his phone and was able to take a picture of 3 pages in 1 minute. It was suggested that digital copies be labeled by the name of the tribe matriarch or patriarch followed by the page number. (For example: Alice-page 1)

#### Varslek

Family members were asked to send family updates to Leslie Stratton who is taking over from what Dick Sundt had previously created. The Varslekt web page for addresses and phone numbers is maintained by Jim and Betty Kay Constand. Updates should be sent via email to Betty Constand at <a href="mailto:betty\_constand@msn.com">betty\_constand@msn.com</a>.

Leslie Stratton reported about the Varslekt, noting that 3 Ring Binder software doesn't work well. Leslie Stratton requested information about graduations, births, deaths. It was reported that 3 Ring Binder software (for VarSlekt) doesn't work well. It took 20 hours to get the format able to be printed as such there is a need for a software upgrade. The idea of using Ancestry.com was floated. Jackie Sundt moved to allocate up to \$100. for the purchase of software. Linda Nordgulen second the motion which was approved unanimously. Each tribe was asked to send an email with all updates. It was suggested that the contact for updating the scrapbook be the same as for updating the Varslekt. Leslie Stratton stated that she is equipped to update the historical records.

All family members were encouraged to write a narrative. The 4th generation family members were urged to read the hard copy of the Varslekt.

Tom Mitchell asked what format is preferred for sending updates. Leslie Stratton stated that Word documents are preferred. One representative should be appointed for each tribe to provide an update for the Varslekt. Leslie Stratton was thanked for her amazing work for the family. Jim and Betty Kay commended Leslie for being the glue that keeps us together. They reiterated it is important to let them know when you change your email or phone number.
