**Dear PRIME MINISTER & leadership colleagues**

**FINAL LETTER OF DEMAND: SETTLEMENT OF IP THEFT AND PROTECTION OF  
NATIONAL & HUMANITARIAN INTERESTS**

To confirm my previous advices and being necessarily blunt:

1. You and your peers have stolen my Intellectual Property and I will pursue that to settlement and/or perdition through political and moral suasion as was settled with Baird
2. You made the same promises as Baird and Turnbull about congestion, affordability, regional prosperity, “care for Sydney” and the like, but contradict every one through your and the Treasurer’s/Gaetjens’ Budgetary and MYEFO processes
3. You specifically follow Berejiklian into harming “Morrison’s Backyard” as well as Newcastle, Wollongong, Western Sydney and Geelong *inter alia*

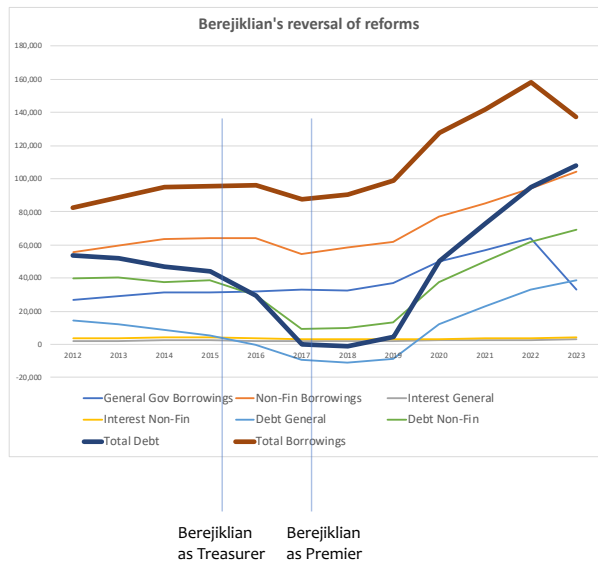
You married your fate to Premier Berejiklian’s at a time I had been and have continued to forensically demolish her credibility, and rightly so. There was a “separation of function”

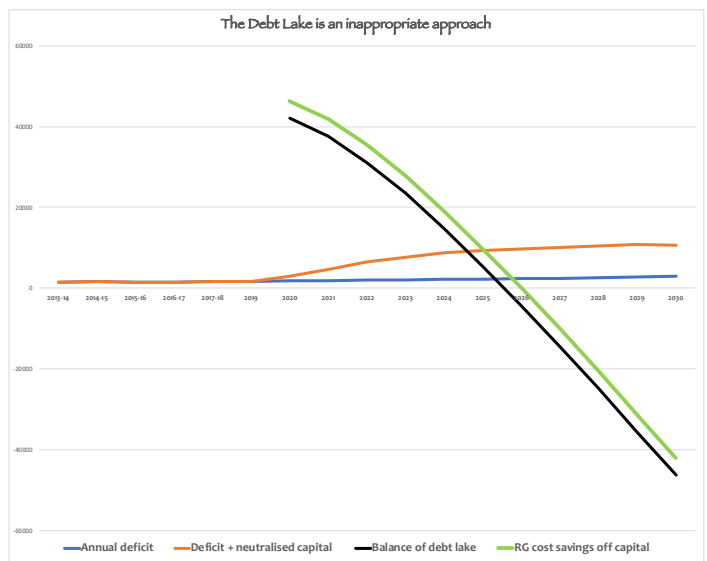
Not one of these Treasurers, including Baird, functioned as “guardians”.



Note that the reduction at the end of the General Borrowings is fictional when Berejiklian’s promises are considered, and here is the correction:

The SMH is in error in saying that Berejiklian has a cash problem with her immediate priorities. She has much greater problems than that:

1. WestConnex has a fatal design error at Rozelle and cannot proceed
2. The Metro projects have a fatal design error in the central zone and cannot proceed
3. The West Metro is markedly inferior to Greiner’s and my reworking of the Bradfield legacy system at lower cost and risk and with more effective results
4. The “debt lake” is contrary to every prudential principle and will cripple future generations which will also have to re-engineer the main project/assets
5. The Northern Beaches Link is markedly inferior to my scheme of 2008 which Baird approved and stole, wasting an extra 12 years on top of decades of broken promises, and damaging the lifestyle and ambience of a very special part of Australia
6. Across the board, rejection of proper due diligence and iNSW/iA protocols meaning waste of at least \$40,00,000,000 and forcing crippling imposts onto future generations.
