

THE ATTEMPTED MURDER ON FRANK'S LIFE

The events described below, and those that follow, took place at the Richland Correctional Institution in Mansfield, Ohio between March 11, 2022 and May 17, 2022.

My Fellow Americans:

Recently there was an attempt on my life by two (2) inmates: Brian Damont Henley (#A485-121) and Calvin D. Felding (#A693-707). Both men are currently incarcerated for violent crimes. Henley brutally raped and sodomized a woman by force (DOC #01). Felding committed felonious assault with a gun specification (DOC #02).

With Henley's current case out of Montgomery County, his Trial Judge declared that he: 1) was "particularly brutal"; 2) "inflicted enormous pain" on his victim; (DOC #03 at [P*49]); 3) "posed the greatest likelihood of committing future crimes"; and 4) had a "prior criminal background" (id. at [P*53]). Furthermore, in the past Henley was accused of raping three (3) prostitutes and was declared a "Sexual Predator" by the

Trial Court (DOC # 04).

Felding was sentenced out of Cuyahoga County and his original charges included "Weapons Under Disability" (DOC # 02). As to his plea deal, I have provided, with the help of others, (DOC # 05) for your review. (see Fn.1 below). Unstable.

The scary part? These animals have outdates. Henley gets released on 06/03/2026 (DOC # 01), and Felding leaves on 11/25/2026 (DOC # 02), while this Innocent Man sits in prison (Free Frank P. Wood @ Facebook).

Go right back to the hunt.

Prison is society's necessary evil. As a victim of a violent crime, I get it.

Regarding the attempt on my life, on 03/11/2022, after 18 months of trying to hedge me into a fight, Henley, with Felding's assistance, attacked me from behind with a padlock as I left the shower. The first hit rendered me unconscious. The second hit woke me up. I was facing down and away from Henley as continued his brutal assault. I protected my head with my arms. At medical I had several lacerations on my head glued shut. The laceration on my outer right wrist is a defensive wound. Pictures were taken by Captain Prichard. All but Henley's first strike is on camera.

Upon leaving medical, I was taken to Segregation, a.k.a. "The Hole." CO Bowman came to me and asked how I felt about celling with another victim of assault. Having been declared "the victim" in my situation, I consented. I was then placed in the Temporary Protection Unit (TPU). When I got to cell TPU 136, I met Inmate Dallas. He

informed me that Bowman asked him the same question. Dallas was also attacked with a lock. The lacerations on his head were so bad that he had to be taken to an outside hospital to have his headwounds stapled shut.

To eliminate any DDRC liability, I was charged with fighting: a Rule 19 violation. To date, I am the only one in this matter to **REPEATEDLY** request to see the Highway Patrol and to take a polygraph.

As I was cuffed after the assault, and leaving the housing unit, I heard CD Hicks say, "I didn't know what was going on until the cart hit the wall." Then how did they know to cuff Henley? He slipped out the other restroom door and back to his rack before they cuffed him. Someone told the truth. And it was most likely **"Red"** from Rack 2-A-1, for he was in there at the time of the assault.

After I left TPV six (6) days later, I learned that the bogus RIB ticket was **"never investigated"**. So my sister called the Highway Patrol.

On 04/18/2022 my sister spoke with Det. Butler from

the Bucyrus Highway Patrol office. He said he was never told about this, that his office is responsible for the investigation, and that he would look into this and meet with me.

On 04/26/2022 I sent an e-Kite to the Warden's Assistant: Michelle Turner, requesting the Voluntary Statement that I filled out and signed after I left medical while still in shock from the assault. I also requested to see the Highway Patrol, again. Having responded to my legitimate requests, you can see that her reply was evasive and irrelevant to the matter at hand (Doc #06).

On 05/06/2022, Det. Butler spoke with prison officials **ONLY**.

No honor there, eh?

Shortly after his meeting with prison officials, Det. Butler called my sister and claimed he looked at the medical reports and, since no weapon was found, this would go no further. To the contrary, not only have I conducted enough legal research to confirm

that Henley and Felding can easily be convicted of attempted murder, felonious assault, assault, kidnapping, and complicity, any medical examiner can easily determine what type of weapon would inflict what type of wound in this specific environment, and any prosecutor can indict on a medical report. With ODRC records of previous felonious assaults/attempted murders with padlocks matching my lacerations, and statements and pictures and cameras proving what I say, they have something to hide. We'll get to that in just a moment.

Det. Butler tarnished his badge as he was derelict in his duties by deliberately failing to interview me. This assertion is true because

The truth is best discovered by seeking answers on both sides of the question,

and

A one-sided inquiry will always arrive at a one-sided conclusion.

Nepotism. Favoritism. Fraternity. There's your conclusion.

With that said, I will now answer Cicero's ultimate question: "Cui bono?" and show "Who benefits?" From this cover-up.

About an hour prior to the assault, Henley got into a very heated argument with my housing unit's case manager: Ciani Bishop. Henley was complaining afterward that he was being moved out of the unit for "causing too many problems," and that "someone is going to have to pay for this." Per protocol, Henley should have been cuffed up for a "cool-down" period. As this never happened, such failure permitted the attempt on my life. I have witnesses to this, but they are afraid to come forward.

To date, Bishop has yet to come forward and tell the truth. Remarkably, she actually runs the Faith-Based program here. A true state of hypocrisy because, as I once read in the Scriptures, "If you don't do what you know you ought to do, you sin."

But Ms. Bishop is not the only beneficiary in this

cover-up. Let us press on.

In the past, here at Richland Correctional, Henley had verbally assaulted female officers and intimidated male officers while in cuffs (DDC #07). They knew about this, and yet did nothing about the verbal altercation with Ms. Bishop. Still, I could care less about the cover-up. All I want is Henley and Felding properly convicted of the crimes committed against me. The longer they stay behind bars the longer it will be **UNTIL** they hurt someone in the **Free World**, again.

People always return to "Their Habits and Their Haunts."

After the assault, Felding is on camera running in and out of Sgt. Viner's office, **multiple times**, telling Viner the story he wanted to hear. And, despite several people telling Viner that Henley attacked me from behind, Viner wrote the bogus Rule 19 ticket based on Felding's lies and Viner's ulterior motives for revenge. Having said that, let's go there.

Back in November of 2018, I was in Housing Unit 5-Lower: Viner's Unit. Tension was building with gang members. Outnumbered by a ratio of 19:1, I asked for a move, for I had to see the Parole Board in about eleven days and was looking to avoid trouble. Viner was busy and eventually went home for the weekend. I then explained my situation to Captain Adams who moved me to 2-Lower an hour later. What I did not know at that time was, that sergeants had to "Release" you from their units, and my move was like putting a bad mark on Viner's record.

About a week after my move, two (2) Inmates told me, "Viner's pissed off you moved out of the unit. He said if you ever come back, he'll put you in 5-upper." 5-upper is a dangerous place to be for this old man.

After the Covid lock-down here ended, I was standing outside waiting for the main library to open so I could gain access to the law library. Viner stopped the CO who was headed to

open the door, nodded at me, and then told him, inter alia, "don't open it." The CO told us to leave.

Compatriots, I spent my first seven (?) years of Wrongful Imprisonment reading lips to watch TV. Got real good at it and still do it to this day. Throw in my education on ASL, Emotional Intelligence, psychology, sociology, and Terrorist Interrogation - I can Base Line anyone. Yes, everyone has Regulators and Adaptors, and will ultimately display cultural- and gender-based characteristics. Even conspiratorial gestures! Yes, people are so easy to read when they display body language, hand gestures, facial expressions, changes in facial color, and changes in accent, tone, or inflection. Yes, it's quite irritating, like a rash, when people insult my intelligence. Indeed. I was tested twice at an IQ of 138 and declared "borderline genius-philosopher." With that on the table,

Rule #2 in Life: Never piss off someone smarter than you with patience. Especially when he has nothing but time on his hands.

The Kangaroo Court known as the Rules Infraction Board (RIB) actually found me guilty of fighting to protect their own. Yes, after Ms. Albrecht, who was present, said, "But he's the victim." The Lieutenant in charge then whispered something to her; and he was wearing a GoPro. That whisper was recorded. After that hearing I found Ms. Albrecht and Ms. Bishop whispering outside of my cell: TPV 136. "Faith without works is dead."

Before proceeding, I'm not say that all prison officials are evil. Need to make that sonically clear. I have met some great people who work for the ODBC. They have my absolute respect. Flipping to the other side of the coin, there are some who are a traffic stop, a hard drive check, a tox screen, a pat down, or a dog sniff away from being in here. They're human. Not infallible.

Readers, I have provided for you a complete history of events, including my appeals, as (DOC # 08) at www.FreeFrankPwood.com under the caption "Attempted Murder on Frank's Life." These documents reveal that

I appealed the motivationally-driven Fighting charge to the prison twice. With twin denials, I then filed an appeal to Columbus. On 05/17/2022, Columbus denied me to protect their own (DOC #09). Their lame excuse was that I did not use the right appeal form (the one that says "Notice of Appeal" on it that was printed from my Sergeant's computer at my request), and that I submitted "41 improper pages" (id.). Really? I am not allowed to submit evidence on my behalf?

Obstruction of Justice is a **felony**.

Again I ask, "Cui bono?" Everyone who failed to act, attacked me, wrote the bogus fight ticket, upheld the ticket, and denied me requested appellate relief had something to gain. To clarify, everyone but me had something or someone to hide, gain, and/or protect. What more, Henley and Felding are loose on the prison yard. And they're cocky enough, stupid enough, to do this this to another Inmate or Staff member.

And to think, **YOUR TAX DOLLARS** paid for this. Just like they paid for my Wrongful Conviction and continue to pay for my Wrongful Imprisonment.

MEDICAL: My skull was never x-rayed and there was no CT Scan. In pain with a concussion, no one woke me up every four (4) hours per concussion protocol. It was my hyperactive prostate, the curse that became my blessing, that woke me up and saved my life. Considering, Liam Neeson, the great actor, his wife bumped her head skiing. Never checked or treated for concussion, passed two (2) weeks later. Tragic! Could have been me, as well.

I have been to medical twice about the head injuries since the assault (Doc #10). What more, to date, the left side of my neck keeps locking up. Pain shoots down into the left bicep. Remember, Henley is left-handed. So when he struck from behind, the first blow struck the left side of my head. Now you understand why I was face-down and facing away from him during the attempt on my life.

Henley is about 6'1" and 220 lbs. I am 5'9" and 150 lbs. The coward had to attack me from behind? Listen, Henley is a true narcissist and a loose cannon. Since I have known him, he has constantly accused small-framed men like myself with, "He's looking at my dick!" "You're stalking me!" "He's licking his lips at me!" I'm trying to **warn** you, **People**. His out date draws near. He's coming home. Soon. And he's coming home more twisted and depraved than when he came in. Yes, a sociopath.

YOU HAVE BEEN WARNED!!!!!!

PSYCHOLOGICAL: I met with Mr. Fodor at mental health on 04/26/2022. I told him what I was going through since the attack: stress, anger, depression, anxiety, **withdrawn**, sleeplessness, forgetting things, and the like. Yes, despite my education, I knew to seek an unbiased opinion, from a higher mind, in regards to what was going on in my mind because **"I'm not me."** He gave me a document pertaining to being a victim of a violent crime and trauma (DOC #11). As (DOC #10) confirms, I have been experiencing a plethora of the symptoms presented

by the CDC (Doc # 11: bottom of p.1). Obviously, I'm not making this up. I am doing better these days, but not fully recovered. It's a process.

The animals in prison that hurt women are weak men; ignorant cowards. *You should see them.* They gravitate towards one another and herd together like beasts. They target, plan and plot against their next victims. They do the same things out there. Birds of a Feather. I deem such animals, and those who did this to me, to be "*Less Thans*," for they are less than animals. They will destroy someone or something if they can't have or control the person or the object so no one else can. *Wrongfully Imprisoned since 2006*, I have seen this pattern repeat itself all too often.

My family's love and support through this has been nothing less than EXTRAORDINARY. Thank you, Loved Ones. You're the best!!!
