The Oaks School's overhead expenses continue if there is a withdrawal, transfer, or termination of enrollment, so if a student withdraws from the school for any reason, the balance of the yearly tuition will become immediately due and payable in full. The school does not refund tuition or other costs for lack of attendance.

<b>Late Payment:</b> For payments not received by the 5th of the month, a late charge of \$25 will be added.
