## Enrollment Contract for 2026-2027 (Enrolled 2026)

I (WE), the undersigned agree to pay the stated amounts of tuition to The Oaks School in full according to one of the payment options chosen below:

Monthly Payments: (12) First payment is due on June 1, 2026; final payment due on May 1, 2027.

Annual Payment: First payment is due on June 1, 2026

Bi-Yearly Payments: First payment is due on June 1, 2026; final payment due on Dec. 1, 2026

I plan to apply for The Choose Act. (If you receive funds from The Choose Act, tuition will be paid in full by the state in July of 2026. If your application is not approved, then one of the other 3 payment methods can be selected at that time).

**APPLICATION FEE:** \$200/student

**SUPPLY AND BOOK FEE:** Due June 1, \$700/student

***Even though the tuition may be paid in installments, this does not constitute a fractional contract. The enrollment agreement is for the full year, and the obligation to pay for the full year is unconditional, without reduction or remission. The Oaks School's overhead expenses continue if there is a withdrawal, transfer, or termination of enrollment, so if a student withdraws from the school for any reason, the balance of the yearly tuition will***

***become immediately due and payable in full. The school does not refund tuition or other costs for lack of attendance.***

**Photography:** The Oaks School retains the right to use any photography and video of school activities and students (both candid and prearranged) for promotional, publicity, advertising, and marketing purposes. No additional notification is deemed necessary with signing of this contract.

       *Please check this box, if you do not authorize the use of photography or video of your student.*

**Monthly Payment:** If paying tuition monthly, an automatic payment plan must be set up through our school payment system.

It is agreed that in the event the undersigned shall fail to pay any one of the installments as chosen herein, then all the remaining installments shall at once become due and payable and The Oaks School may treat them as due and payable without further notice to the undersigned.

**Late Payment:** A late charge of \$50 will be applied for payments not paid by the 5th of each month. For payments that are more than 30 days past due, an additional late payment of \$100 will be charged. If an account is more than 90 days past due, students will not be able to attend school or participate in school events until the balance is settled.

**Communication:** I understand that The Oaks School desires to build a healthy community of families with good relationships at The Oaks School, so I will work to address any concerns with teachers or administration in a positive, constructive manner.

**Liability Release:**

I affirm that I am the parent or legal guardian, and or financially responsible party of the student(s) named above.

I understand that The Oaks School and its Administrators, Agents, and Employees will in no way assume responsibility financially or otherwise for legal action that may be taken against any family associated, enrolled, or otherwise admitted to The Oaks School.
