## I. Call to Order

#### **IV.** Treasurers Report

Income: \$37,604.04 Association Expenses: \$21,348.92 Recreation Expenses: 20,437.68 Net Income: (\$4,194.56)

Association expenses jumped due to insurance premium of \$6,636.85 being paid out Recreation expenses jumped due to insurance premium of \$10,470.60 being paid out

# V. Old Business

a) Insurance Renewal – Premiums for 5/23 -5/24, in the amount of \$17,107.45 have been paid

b) Fining Process Draft – Fining process drafted and reviewed

c) <u>Budget Shortfall</u> – Transfer of funds from contingency to cover shortage from budget due to rising costs of insurance, electric, water etc. vice placing a Special Assessment on lot owners. President and Treasurer met at Truist Bank to complete the transaction on August 18, 2023.

# VI. New Business

a) <u>Review Fining Process Draft –</u> Final Draft was reviewed / discussed. Past notices have been warning letters only with some compliance. In accordance with our Governing Documents and F.S. 720.305(2) notices can be sent out and can include up to a \$100 a day fine for violations that fall within the Governing Documents, not to exceed \$1000 in the aggregate for continuing violation. No notices for fines have been sent in the past but language in notices will state that Lot Owner "may" be fined. Draft approved and new violation notices will go out in the future.

## VIII. Adjournment

The meeting adjourned at 6:10 p.m. The next Board meeting will be held on December 13, 2023 at 12:00 p.m., at the WFCA Long Lake Park club house. The earlier time slotted for this meeting is due to travel and work schedules of several board members.
