- 7. **Registration of HOA as required by Florida Statute Changes:** It was agreed that Juan Riquelme would look after the online registration of the Association with the Florida DBPR, which needs to be completed this week.
- 8. **Certification of new Directors:** In accordance with the new Florida regulations, all new directors must now attend a course on HOA management or certify, in writing to the Board, their knowledge of the HOA's CCR's and By-Laws. Nancy Hampson will look into these requirements and prepare a proper certificate to be signed by new board members and kept on file.

- 9. **Property Insurance**: The board members discussed property insurance for the HOA buildings and agreed it would be prudent to obtain such insurance, particularly fire insurance. Nancy will contact Edens Insurance and ask Matt to reconfirm the proposal from last summer.
- 10. **Annual Meeting:** the 2014 meeting will be held Feb 4 2014 at 7 pm. Nancy will try to secure Hampton Inn again or arrange for appropriate facilities.
- 11. Newsletter and Notice of Annual Meeting: Nancy will prepare draft newsletter and email it to Juan for completion. Once winners of Christmas Decoration Contest have been determined, newsletter can be completed for mailing. Juan and Harry will look after judging of the Christmas decorations. Juan will look after getting newsletter to printer.
