Playground

Three different playsets discussed from left coast Recreation, average cost of \$10,000 to replace current set. We currently do not have enough money in the bank to purchase and install a new set. Options moving forward include: Capital improvement, one time increase in dues requiring discussion and vote; Seeing if there is an option to finance by providing a significant down payment and then lower monthly payments; Also discussed a PayPal donation with yearly dues as option for residents. The board also discussed researching a second company to compare playsets and pricing. Each board was asked to review the current options provided and submit their preference in an effort to move forward with a plan to discuss as a neighborhood.

General Maintenance

The entry sign is in need of painting. The original plan was for the board to do this, but time constraints have made that challenging. We will instead obtain an estimate to repaint the High Pointe II sign at the front of the community. Corlis Painting is who previously has done this for the neighborhood. Allison will call for estimate.

As winter approaches, the board also addressed the possibility of having an outside company plow our neighborhood since we are low priority for the county. Based on the lawn and garden companies in the community, His Hands is a company in the community that provides plowing services. Allison will call for an estimate.
