# **President's Report**

No formal report; moving on to treasurer's report.

## Treasurer's Report

- 1. Discussed proposed budget draft for 2025. Increased insurance 3% for expected inflation. Post office box slight increase to account for possible inflation.
- 2. Proposed budget has a Reserve of \$4,787 to be used for future expenses and potential stair rail for the playpark area.
- 3. Discussed possibly increasing the budget potentially to \$1500 for landscaping maintenance due to dying plants in the common areas of playpark, specifically Juniper bushes and plants near the neighborhood entrance sign.
- 4. Entrance sidewalk strips adjacent to respective homeowners discussed if the HOA will continue to pay for maintenance and cost of these strips. As of right now the answer is yes we will.
- 5. Explain to the neighbors at the neighborhood annual meeting what we are expecting for future HOA costs such as, replacing leaning mailboxes structures, handrail at playpark,

dead junipers, possible swing set replacement in the next 5 years or so. This is what the Reserve in the budget is to be used for or to help save up for (\$4,787).

Kathryn Schultz motions to approve the treasurer's report. Bob Flynn seconds the motion all in agreement. The motion passes.
