Minutes of the Meeting of the Tresmeer Parish Council held at the Village Hall, Tresmeer on Monday 8<sup>th</sup> December 2025 at 19.00

## Public Participation.

**3. Minutes of the previous meeting:** **64/2025**  
Cllr P Rose proposed that the Minutes of the meeting held on Monday 24<sup>th</sup> November 2025 at 7pm be signed as a true and correct record This was seconded by Cllr N Bellis and agreed.

**4. Matters arising from the Minutes:** **65/2025**  
(a) **Tansun heaters** re Village Hall. Cllr Bellis reported he had reached out to local electricians to obtain quotes for the installation of the proposed new heaters, but had received limited responses as they appear very busy at this time of the year. He will chase up again. It was agreed that the Village Hall Committee would take the lead on heating required for the village hall. The Parish Council will provide advice and guidance as needed. It was clarified that the Village Hall Committee would need to investigate options to obtain the required funds."

(b) **Land at Splatt.** Clerk reported that he had a Teams meeting with Cornwall Council (CC). and that CC had had received 'Expressions Of Interest' (EOI) from people in Splatt regarding the land for sale. CC will come back to the Parish Council, if necessary, at a later date.

**To decide on the precept for 26/27.** Cllr B Shirley proposed a small increase of the precept to £4,000. This will mean a 0.71p per month increase on a Band D Property. This was seconded by Cllr D Bettesworth and agreed.
