8/06/25 **Planning** - Cllr Fuller brought up concerns regarding the repowering of Cold Northcott and in particular the size of the turbines in relation to the size they are replacing. He expressed concern that the Parish Council had not voiced their opposition to the planned development. At the meeting we had regarding this there

were people from the surrounding area who attended also the developer, despite ample opportunity there were no objections voiced and the only remarks made were positive and in favour of the development. Members of the public who attended the meeting today were also positive in their support for the proposed development. Cllr Fuller was advised that he can as a private citizen put his objections to the Planning Committee. Cllr Bellis advised that as this development falls well within the criteria from Central Government that this is highly likely to be passed.
