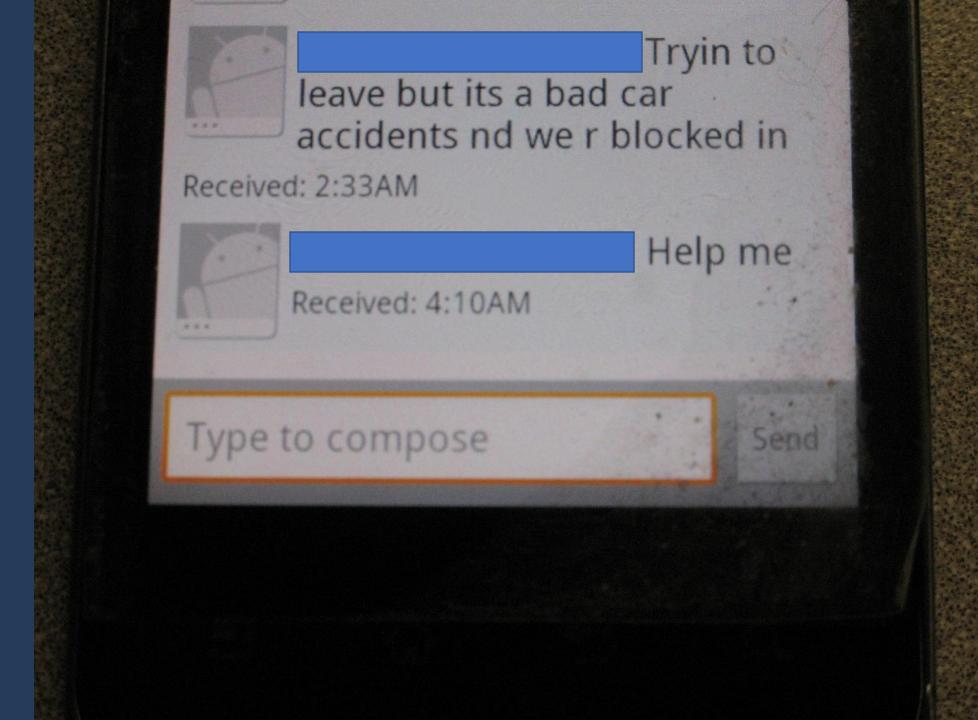

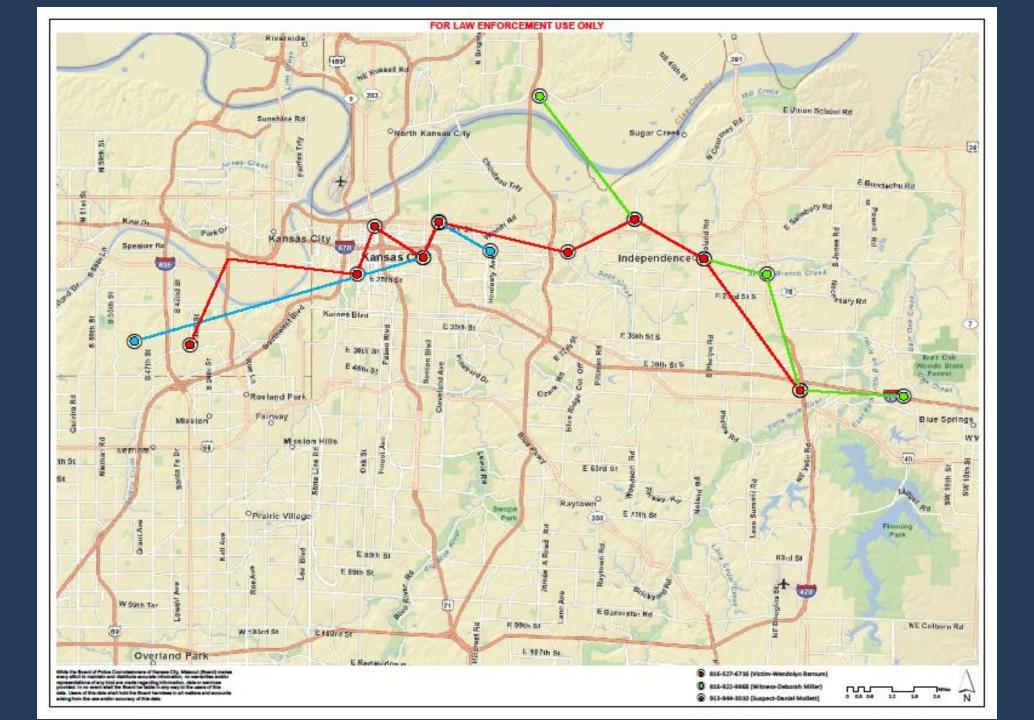

The Suspect as a Crime Scene

Evidence can be collected by a forensic nurse, an investigator, or crime scene technicians.

- Consent
- Search Warrant
- Collect the clothing.

Do men and women communicate differently?



Trauma Informed Interviews

- Purpose is to help parties retrieve & share memories.
 - Investigators document and evaluate the information in context with everything else they know about the case.
 - The goal is to capture the most information possible.
 - Follow-ups may be necessary.
- Victim needs are safety, control, trust, understanding, and compassion.

Trauma Informed Interviews

A trauma informed interview should:

- Establish safety, trust, and build rapport.
- Encourage disclosure using non-leading, open-ended techniques.
- Put the Victim in the driver's seat.
- Allow for pauses and silences.

Practice patience, empathy, and understanding!

Preparing for the Interview

Determine:

- Where the interview will be conducted.
 - Choose a location that is private and free of distraction.
 - If using an interpreter, ensure the site has reliable internet.
 - Should be <u>separate</u> from the forensic nurse interview.

Preparing for the Interview

- Utilize Victim Advocates.
- What, if any, evidence will be reviewed with the party.
- Prepare a list of open-ended questions/topics.
- Will you be recording?

Prepare Victim

- Let the Victim know what to expect.
- Ask how they want to be addressed.
- Explain the interview is not intended to be a question/answer session.
- Explain if you will be taking notes.
- Ask the Victim to share what they remember in the order they remember.
- Explain follow-up questions may be necessary.
- Honesty is important.
- Breaks are perfectly acceptable.

The Interview

- Leave personal biases out of the interview.
- Pay attention to the verbal and non-verbal cues.
- Encourage the Victim to start where it makes sense to them.
- Do not ask the Victim to tell their "story."
- If the Victim wants to share information they were provided by someone else, clarify where it came from.

What does it mean to use Active Listening Skills?

- Avoid interrupting Victim.
- Pause before asking follow-up questions.
- Do not rush the Victim be comfortable with silence.
- Be patient.

DO ask:

- What did you say when...
- What did you do when...

- ✓Do **not** ask:
 - Did you say no?
 - Did you say stop?

Reconstruct the circumstances with the Victim.

- Understand how the incident began, what occurred during, and how it ended.
- Get to know the Suspect the way Victim knew them.
- Ask the Victim questions that will provide information regarding the environment.

Ask questions that require they use their 5-senses.











- Elicit information about what the Victim experienced emotionally as well as physically.
- Clarify information and details after they have shared their experience.
 - Avoid leading questions.
 - Instead ask, "Tell me more about..."

- Avoid "why" questions.
- Begin follow-up questions using professional terminology.
- Use the language of non-consensual sex.
- Be careful when asking questions regarding time and distance.

Remember:

- A perpetrator will only use the amount of force necessary to control the Victim or prevent them from resisting.
- Consent cannot be given if a person is drunk, unconscious, asleep, frightened, or otherwise unable to indicate a willingness to participate.

What is wrong with the following statement:

Victim performed oral sex on Suspect.

Victim said, "[Suspect] grabbed me by the hair and shoved my face on it."

What is a necessary follow-up question?

Did [Suspect] put his mouth anywhere on your body?

Did [Suspect] have you put your mouth anywhere on his body?

- Balance questions.
- Obtain exact quotes.
- If there has been prior consensual sexual activity, ask questions to understand how the reported incident(s) was different.
- Be patient Victims may have limited memory.



Ask the following:

- Were they taking any over the counter meds and/or dietary supplements?
- Were they taking any prescription drugs?
- Were they taking any illicit drugs?
- Were they using marijuana?

*Remember, we are not trying to prove what was used. The goal is to understand level of ability to consent.

Interviewing the Victim

Ask the following,

- What did they eat?
- When was the last time they slept?
- Did they see the drinks being made?
- What size glass was it served in?
- Was the Victim aware of what was happening to them?
- Does the Victim have a physical or mental disability which prevents them from being able to form consent?
- Was the Victim conscious? Or unconscious?

Interviewing the Victim

Ask the following,

- Was the Victim physically powerless and unable to resist?
- Was the Victim able to communicate consent or lack of consent?
- Was the Victim asleep? Passed out?
- Was the Victim able to walk, talk, drive, etc?
- Was the Victim's speech slurred?
- Was the Victim's behavior consistent with their personality?

Interviewing the Victim

Ask the following,

- How did the Suspect interact with the Victim? Others?
- Did the Victim have any interactions with the Suspect?
- Does the Victim have any history with the Suspect?
 - How does the Suspect "normally" act when they drink/use drugs?
- Who did the Victim first disclose to? (outcry witness)

Concluding the Interview

- Ask if they have any questions.
- Re-explain the process and next steps.
- Advise it is normal to remember information and/or to have questions after the interview.
- Explain you may have follow-up questions.
- Provide contact information for the Victim Advocate.
- Ask how frequently (and by what method) they wish to be updated.
- Thank the Victim for sharing their experience.

- The Suspect should be the last person spoken to in an investigation.
- Determine if a translator is needed.
- He primary case owner should lead the interview.
- Develop rapport.
- Let the Suspect tell their version of events without interruption.
 - Address inconsistencies after their have finished.

- The Suspect should be asked the same questions as the Victim.
 - Ask the Suspect the same background questions the Victim is asked to establish their level of incapacitation (or to prevent the claim of incapacitation later).
- Ask the Suspect about the Victim's behavior.
- Have the Suspect describe their interaction with the Victim and the Victim's interaction with others.

What did the Victim say or do that led them to believe

they were a consenting partner?



- Was the Victim "awake" or were their eyes closed?
- Was the Victim saying or doing anything that would appear to be consistent with consent?
- Have the Suspect describe how he or she and the Victim left the location and how the sex acts began.
- Who did what to whom?

- Have the Suspect be very descriptive about the events to include the removal of clothing.
- If a condom was used (including where it came from and who applied it), the positions, etc.

- Ask the Suspect to describe how the encounter ended.
 - What did he or she say/do?
 - What did the Victim say/do?
 - How did the Victim and/or Suspect leave the location?
- Prepare to follow-up with the Victim if needed.

```
Do not ask the Suspect:
"Was it consensual?"
"Did you..."
```

```
Instead ask,

"Tell me more about..."

"What were you thinking before..."

"What did the Victim say/do..."
```

Other Interviews

Witnesses will be able to provide insight into the Victim and the Suspect's behavior, both current and historic.

- Outcry witness(es).
- Witnesses who saw the Victim or Suspect before or after the incident.

Effects of Drug and/or Alcohol Facilitated Sexual Assault

- The Suspect creates a victim's vulnerability.
- Onset of the effects are typically rapid.
- Victims may experience an altered level of consciousness.
- Victims may suffer anterograde amnesia.
- Victims may not self-identify as victims.

The Victim may...

- Blame themselves.
- Struggle with lack of memory.
- Often feel re-victimized due to the amnesiac effects of the drugs.
- Drugs and alcohol can affect the way a victim presents to law enforcement and medical personnel.
- Are unable to detect risk cues.

The Suspect may...

- Be manipulative.
- Work alone or in pairs.
- Avoid confrontation.
- Use very little (if any) force.
- Minimize responsibility.
