Dear Community of Faith:

Most people within our ranks are not worried about forcing people to believe like us; neither are we against people who have a differing viewpoint.

We are not anti-anything, other than anyone or any entity that seeks to take away our rights and freedoms, those afforded to us through the Bible and also those protected under the United States Constitution. The power to name is the power to control. Depending on a name, we may be positioned as an instant ally or enemy. Frightfully, some designations and labels can lead to deadly ends. Anti-vaxxer is one of those names that has weakened our position in this fight and strengthened the position of the opposers of our beliefs. I am asking you to help spread the word of who we are and what we accurately reflect, Conscious Faith Objectors (CFO's). Our mission—to consciously demonstrate what we believe according to our faith and object to anything or anyone that hinders its progress.
