

**AFFIDAVIT OF EXEMPTION ON RELIGIOUS GROUNDS FROM
IMMUNIZATION MANDATES – PRIVATE SCHOOLS**

RE: Religious Exemption from Immunization Requirements

I, (Name) _____, the undersigned do hereby swear and affirm that I am a member of a recognized religious organization, and that the immunizations required by (Governing Authority Name) _____, are contrary to our religious tenets and practices. On this basis, as the above referenced immunization requirements violate our right to freely exercise our religion as guaranteed by the First Amendment of the Constitution of The United States of America, I am asserting my rights to an exemption from (Governing Authority/School's Name) _____ immunization requirements.

I qualify for this exemption based on the following:

- 1) First Amendment of the United States Constitution
- 2) Many private schools receive funding from the federal government (i.e. school lunch or breakfast programs, remedial assistance to schools with low-income students, technology grants...). When private schools accept this money, they have to obey important federal antidiscrimination laws. *42 U.S. Code § 2000a - Prohibition against discrimination or segregation in places of public accommodation*, which states “All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, privileges, advantages, and accommodations of any place of public accommodation, as defined in this section, without discrimination or segregation on the ground of race, color, religion, or national origin.”
- 3) COVID-19 injections have not been FDA approved. They are experimental and are only approved for “Emergency Use Authorization” (EUA). Clinical trials are ongoing and will not be completed until late 2022 and 2023, making it illegal to order anyone to get inoculated. In order for injections to be mandatory, legislation must be passed. The CDC has also noted that it is illegal and unethical to mandate EUA vaccinations.

Failure to uphold 42 U.S. Code § 2000a and any attempt to coerce an individual to get the Covid-19 vaccine at this time is a violation of federal law and may be met with legal action.
