Additions and Corrections to the regular business meeting minutes presented:

Jeremy Struble motioned to approve the minutes for the regular business meeting held 03/05/2025 with no corrections requested. Travis French seconded the motion which carried by a vote of 3/0.

CORRESPONDENCE PRESENTED FOR REVIEW:

1. Building permit applications/Approvals – were looked over by the Supervisors
2. Equipment show – May 28th at the Driving Park. Karen will attend the session to be given by Terri Cunkle on Internal Controls.
3. Notice of intent to remediate – O'Connor residence-Received notice from Insite Group, Inc. stating that the remediation report indicates that the remediation performed has attained compliance with the Statewide health cleanup standard.

Bills were presented for payment in the amount of \$65,412.61

A motion was made by Travis French and seconded by Mark Collins to pay all bills as presented.

Secretary's mileage of \$31.50 was presented for payment. Mark Collins made a motion to approve the secretary's milage. Motion was seconded by Travis French -Motion carried by a vote of 3-0.

NEW BUSINESS:

A Resolution to apply for DCED Multimodal Grant for Greenwood Road in conjunction with Pine Township was presented by the Secretary. Resolution also names Mark Collins as designated contact/signer on the grant application. A motion was made by Travis French and seconded by Mark Collins to accept resolution.

Donation to Rescue Hose & Ladder Company – Mark mentioned that it would be nice to make a donation to the fire company for their efforts in cleaning up with the storm that recently took several trees down, blocked roads and took power lines out. A motion was made to make a \$1,000 donation to the Rescue Hose & Ladder Company. A letter of thanks should also be sent to Shay Durandetta and Garry Witherite for their efforts in the clean-up.

UNFINISHED BUSINESS

Bids were opened by Supervisors for Stone & contract was awarded to Bucktail Excavators- see log of bids on next page

Resumes: Supervisors to look over resumes received for full-time road maintenance position and let Mark know who they would like to see interviewed.

Grant Update – Need to get the resolution from Pine Twp. to submit with grant application. Karen has received all letters needed from County Planning, Commissioner's, and State Representatives.

Paving Projects –

Bid Packets were sent out on Monday, March 31st for River Road Project. Shawn Agosti from Penn Dot to get us a quote on Bloomington Avenue and we will apply for an LSA Grant for both Greenwood Road and Bloomington Ave-from Ed Bloom Road to Rte 453. Phase 2 of the project.

A motion was made by Jeremy Struble and seconded by Travis French to apply for an LSA Grant in cooperation with Penn Township for Tree Farm Road. Mark added that there is no money this year for daylighting.

Mark is still getting quotes for pole saw. Wants one with circular saw.

Mark also mentioned that he would like to purchase a flail mower - feels he can get one for under \$5,000


