Resolution to apply for LSA grant on other ½ of Bloomington Ave. Extension  
1<sup>st</sup> Travis French 2<sup>nd</sup> Mark Collins. Approved by: 3-0.

**Unfinished Business:**

Floodplain ordinance update. – Solicitor Heather Bozovich sent over a rough draft for the Supervisors to look over. She is willing to meet to discuss the changes needed. Supervisor Struble offered to work with the Solicitor on the ordinance and report back to Supervisors at the October meeting for their input.

Investing \$\$ - CNB Bank/PLIGIT – Supervisor Collins said at this time he feels their best bet would be to just transfer \$400,000 from General Fund into General Fund savings account to accrue better interest rate. Everyone agreed.

Bridgeport Road bridge project Penn Dot is to come up with lay out and see if they can put in cul-de-sac. Supervisors could deny if needed.

Loader quotes Mark received several quotes on a new loader with trade in.

Mark said he'd like to get one for under \$100,000. Travis asked if we can demo – Mark said that we could. A motion was made by Travis French to move forward with limit of \$100,000.
