- A "photo capture" of all license plates entering the community will be implemented in January.

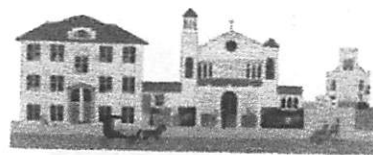

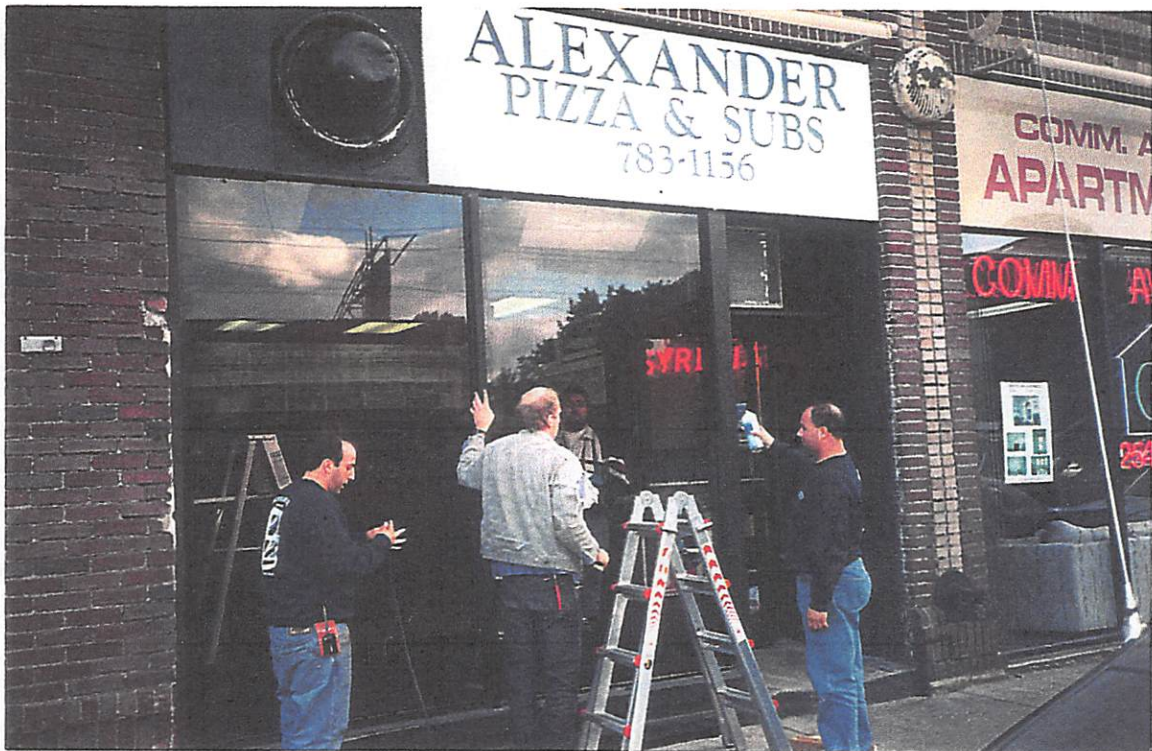

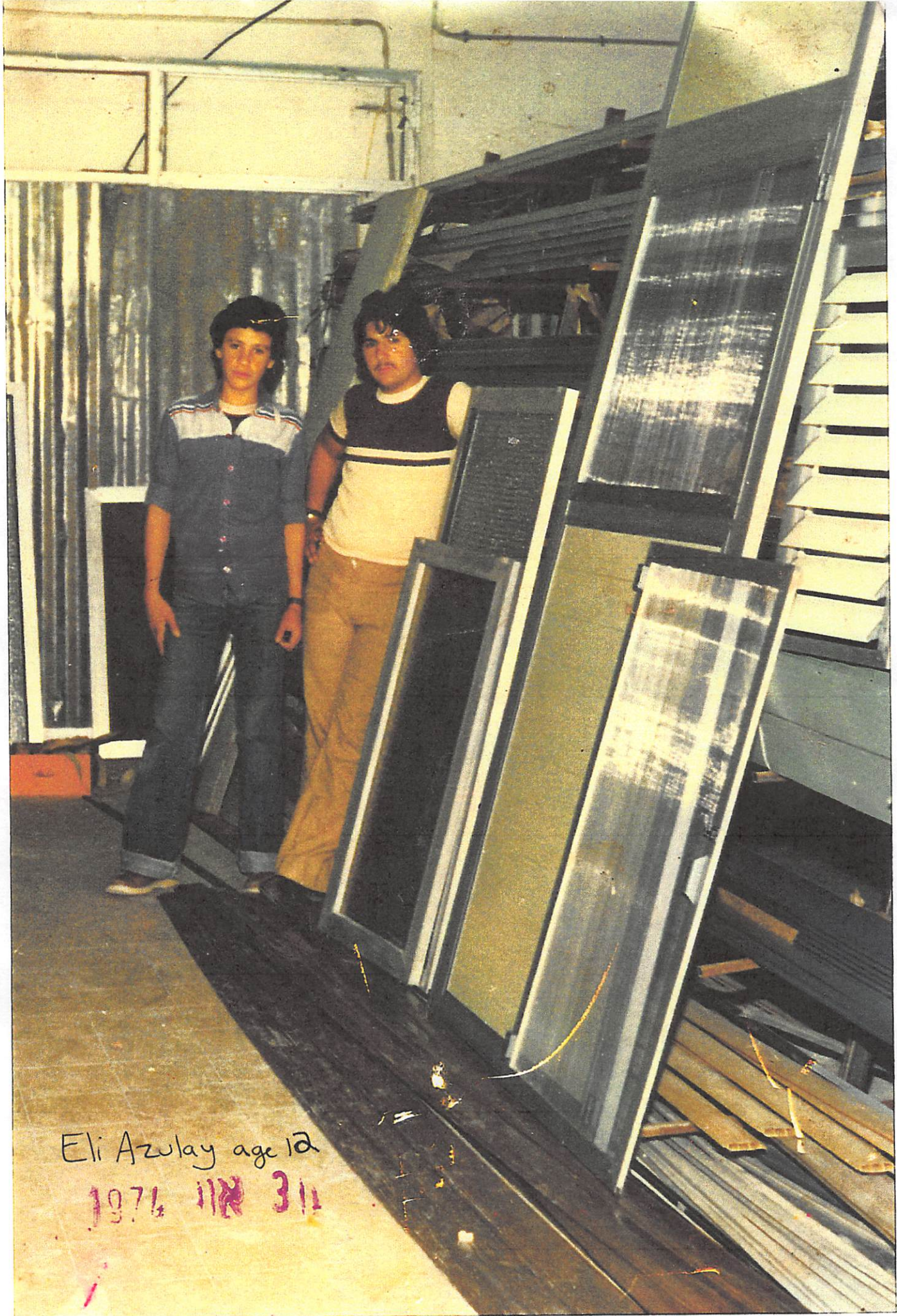
