Paul Disantis called the meeting to order. Roll call taken. Members present Paul Disantis, Matt Allen, Jon Kerr, Andy Kerr, and Damita Peery

Motion made by Jon to approve the February 7, 2019 meeting minutes with the following correction to be made: Damita nominated Andy to be Vice-Chair and Paul seconded the nomination. Correction was made. The Motion seconded by Andy. Vote was unanimous to approve.

First order of business is Application #19-012. Applicant is Plan 4 Land, LLC, 10 West North Street, P.O. Box 215, Ostrander, OH 43061. Property owners are Kenneth and Angela Neverman, 7552 Linder Way, Galena, OH 43021. Property is located on Dustin Road, 1100 ft. west of Ryan Meadow Place, 1850 ft. east of I-71. Parcel # 417-330-01-041-000 (9.05 acres) for rezoning from AG-1 to FR-1. It is currently vacant land.

Parcel # 417-320-010-13-000 (6.35 acres) for rezoning from AG-1 to FR-1. It is currently vacant land.
