Vice Chairman, Andy Kerr announced the following Statement of Policy:

Statement of Policy

Continuance from prior meeting: Application #24-018 AMH Development LLC

Major Modification to the final development plan of Berkshire Crossing that was approved in 2021. James Martin from AMH Development presented to the board a proposed plan to eliminate the pool and club house from the approved plan and add a pocket playground and an additional walking path around a larger retention pond. Also adding a pavilion.

The board expressed the need for a larger pavilion for outdoor gatherings. Austin asked what phase this would be completed in. Andy asked what material the path would be.

Austin made the motion to approve application #24-018 of the following four conditions. Expanding the pavilion to 600 square feet. A 10-foot paved path built to Delaware County Specification. Include updated landscaping plan with plant identification. Add electric power to the pavilion. Jon seconded the motion. Motioned approved 4-0 vote.

Continuance from prior meeting: Application 24-036 NS Partners LLC

Major Modification to the final development plan to the AD Farrow property. The major modification would include a temporary building for the use of selling motor vehicles as is permitted in article 15 under NAICS #411. A temporary building permit for one year would be requested with the option for three additional one-year extensions. Jack Reilly from NS Partners LLC provided an updated plan from the April 4th meeting including 4 sided elevations, color renderings, internal restroom plans, and the restricted layout for parking car inventories. The updated plan included the concerns the board had from the April 4th, 2024, meeting.

Jon made a motion to approve application #24-036 NS Partners LLC. Andy seconded the motion. The motion passed 3-1 vote. Jon Kerr yes, Austin Slattery no, Andy Kerr yes, Matt Allen yes.
